On behalf of Justeq LLC, we are submitting the above referenced notification to revise the eye precautionary statement as requested in the Agency's letter dated May 15, 2013. The eye precautionary statement on page 2 of the label has been revised to read "Wear <u>appropriate</u> protective <u>eyewear such as goggles</u>, face shield, <u>or</u> safety glasses, and chemical-resistant gloves."

As instructed, we are submitting this as a notification per PR Notice 98-10. This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA. Justeq07 is an effective agent for controlling algae, bacteria, and fungi that produce slime in recirculating condensing and cooling equipment and in reservoirs or ponds that serve as the source of boiler feedwater or cooling water. Justeq07 can also be used to control bacteria, algae and fungal slime in decorative fountains, air washers, paper mill water systems, and food, beverage, and industrial process pasteurizers.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES SKIN BURNS. Do not get in eyes, on skin or on clothing. ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless in accordance with the requirements of a National Pollution Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

COOLING PONDS, RESERVOIRS AND DECORATIVE FOUNTAINS

Justeq07 must be applied at the reservoir, pond, or fountain inlet or at a location that permits complete diffusion into the water at maximum retention time before reaching the outlet. Sufficient Justeq07 must be fed to maintain a total chlorine level of 1.0-4.0 ppm in all parts of the reservoir or pond (two fluid ounces per 1000 gallons of water yields about 1.0 ppm total chlorine).

INDUSTRIAL & COMMERCIAL RECIRCULATING COOLING WATER SYSTEMS

Justeq07 must be applied directly to the cooling water at any section of the system where sufficient mixing will occur. Apply Justeq07 to the cooling water to provide a total chlorine level of 1.0-4.0 ppm. Justeq07 at a dosage of two fluid ounces per 1000 gallons of water gives a dosage of approximately 1.0 ppm of total chlorine, but several times that dosage may be required to provide a total chlorine level of 1.0 ppm throughout the systems. Check the total chlorine level with a test kit and additional product applied until a reading of 1.0-4.0 ppm is obtained at the bleed-off point. The product can be added to the system continuously or intermittently or as needed to obtain the above residual. The frequency of feeding and dosage rate will depend upon the severity of the problem.

INDUSTRIAL PASTEURIZERS (Such as food, beverage, and industrial process pasteurizers)

For control of bacteria and fungi in industrial pasteurizers add 4-8 ounces of Justeq 07 per 4,000 gallons of system water to achieve control. To maintain control add sufficient Justeq 07 to maintain 2.0-4.0 ppm total chlorine throughout the system. (Two fluid ounces per 1000 gallons of water yields 1.0 ppm total chlorine).

SHELL EGG PASTEURIZER WATER SYSTEMS (not for use in California)

For control of bacteria, fungi and algal slime in shell egg pasteurizer water systems add 4-8 ounces of Justeq07 per 1000 gallons of system water to achieve control. To maintain control add sufficient Justeq07 to maintain 2.0-4.0 ppm total chlorine throughout the system. (Two fluid ounces per 1000 gallons of water yields 1.0 ppm total chlorine).

AIR WASHERS (This product may be used only in industrial air washers and air washer systems which have mist-eliminating components.)

For control of microorganisms in industrial air washer systems add sufficient Justeq07 to the air washer sump or chill water to provide a total chlorine level of 2.0-4.0 ppm. Badly fouled systems must be cleaned before treatment is begun. Justeq07 at a dosage of two fluid ounces per 1000 gallons of water gives a dosage of approximately 1.0 ppm of total chlorine, but several times that dosage may be required to provide a total chlorine level of 1.0 ppm throughout the system. Check the total chlorine level with a test kit and additional product applied until a reading of 2.0-4.0 ppm is obtained at the bleed-off point. Some systems may be maintained in satisfactory biological condition by applying this dosage once per day while others will respond better to dosages less than once per day.

HEAT TRANSFER SYSTEMS (Such as Evaporative Condensers, Hydrostatic Sterilizers and Retorts, Dairy Sweetwater Systems, and Once-Through Cooling Water Systems)

Justeq07 must be used at the same application rates, and in the same manner as described above. It must be added to the system at a point of uniform mixing such as a basin area, sump area, or other reservoir or collecting area from which the treated water will be circulated uniformly throughout the system.

PULP & PAPER MILL INFLUENT WATER SYSTEMS (not for use in California)

Justeq07 must be applied to the raw water intake prior to the filter house, economizer, or process water. Feed at a dosage sufficient to provide total a chlorine level of 2.0-4.0 ppm. Justeq07 at a dosage of two fluid ounces per 1000 gallons of water gives a dosage of approximately 1.0 ppm of total chlorine, but several times that dosage may be required to provide a total chlorine level of 1.0 ppm throughout the system. The total chlorine level must be checked with a test kit and additional product applied until a reading of 2.0-4.0 ppm is obtained. Some systems can be maintained in satisfactory biological condition by applying this dosage intermittently while others may require a continuous application. Justeq07 can be used in pulp and paper influent water systems where the manufactured paper or paperboard can be used for food contact purposes.

PULP & PAPER MILL PROCESS WATER SYSTEMS (not for use in California)

Add Justeq07 to paper making systems at a point of uniform mixing such as the beaters, broke chest pump, save-all tank, or white water tank. Feed at a dosage sufficient to provide a total chlorine level of 2.0-4.0 ppm. Justeq07 at a dosage of two fluid ounces per 1000 gallons of water gives a dosage of approximately 1.0 ppm of total chlorine, but several times that dosage may be required to provide a total chlorine level of 1.0 ppm throughout the system. Check the total chlorine level with a test kit and additional product applied until a reading of 2.0-4.0 ppm is obtained. Some systems can be maintained in satisfactory biological condition by applying this dosage intermittently while others may require a continuous application. Justeq07 can be used in pulp and paper mill process water systems where the manufactured paper or paperboard can be used for food contact purposes.

STORAGE AND DISPOSAL

Do not contaminate water, food, feed by storage and disposal.

PESTICIDE STORAGE: Store this product in a cool dry area, away from direct sunlight and heat to avoid deterioration. In case of spill, flood areas with large quantities of water. Product or rinsates that cannot be used should be diluted with water before disposal in a sanitary sewer. **Nonrefillable container. Do not refill this container.**

PESTICIDE DISPOSAL: Pesticide disposal wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available or place in trash collection.

FOR RIGID NON-REFILLABLE CONTAINERS - 5 gallons or less:

Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

<u>Triple rinse as follows</u>: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

<u>Pressure rinse as follows</u>: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

FOR RIGID NON-REFILLABLE CONTAINERS – greater than 5 gallons:

Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container to its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment of a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down ever application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the cide of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.
