The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “NOTIFICATION” and placed in our records.

## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

### ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish and aquatic invertebrates. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area.

Drift and run-off from treated areas may be hazardous to aquatic organisms in neighboring areas. Care should be used when spraying to avoid fish and reptile pets in/around ornamental ponds. This product is highly toxic to bees exposed to direct treatment or residues on blooming plants. ## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

*[For use with ½ Gallon and 1 Gallon Sprayer. Not required for 1 Qt. Trigger Sprayer:]*

**To Attach Sprayer:** Open flip cap and firmly insert [red][white] hose tip. Hold sprayer 12 inches from surfaces being sprayed.

After each use turn sprayer nozzle to 'OFF' position and snap back into bottle to avoid leaks. Once trigger is connected store and transport in upright position [to avoid leakage through breather hole].

*[Optional alternate sprayer directions for use with ½ Gallon Sprayer:]*

How to Use: Open flip cap. Remove sprayer from handle. Extend tubing 3 feet. Firmly press hose tip into cap. Slide ON/OFF lever to 'OPEN' position.

**AFTER EACH USE:** Turn nozzle to 'OFF' and lever to 'CLOSED'. Return sprayer to handle. **ALWAYS STORE IN UPRIGHT POSITION.**

**For Indoor Applications:** Apply a 4-inch band along the interior of your home in areas where insects [spiders] are a recurring problem. Spray until slightly wet without soaking.

**For Outdoor Applications:** Apply a 12-inch band along the exterior perimeter of your home. Spray until slightly wet without soaking.

### After you apply

- People and pets may re-enter treated areas after spray has dried.
- Thoroughly wash all food processing surfaces and utensils with soap and water before reuse.
- For long lasting residual control leave spray undisturbed. The product will keep killing for up to 12 months.

[Optional Instructions on Cap: Shake well. Remove sticker. Open flip cap. Firmly insert [red][white] hose tip]

### STORAGE AND DISPOSAL

STORAGE: After each use, turn sprayer nozzle to off position and snap back into bottle to avoid leaks. Store in original container in areas inaccessible to children. Protect container from freezing. ALWAYS STORE IN UPRIGHT POSITION.

STORAGE: After each use, turn sprayer nozzle to 'OFF' and lever to 'CLOSED'. Return sprayer to handle. Store in original container in areas inaccessible to children. Protect container from freezing. ALWAYS STORE IN UPRIGHT POSITION.
