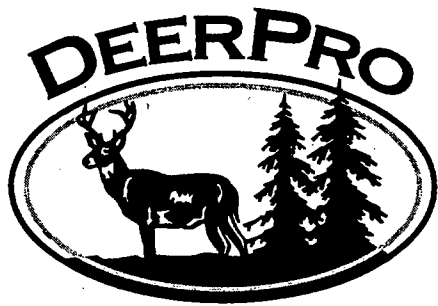

Use DeerPro™ Deer Repellent Concentrate as a repellent to reduce browsing and chewing damage from deer, rabbits, and voles (*microtus* spp.). Repellency results from the odor of treated plant parts. One application will protect treated plants for 3 – 6 weeks, depending on weather conditions. Treat before the expected time of animal damage.

Thoroughly shake DeerPro™ Deer Repellent Concentrate prior to use. Mix one part of formulation with 2 parts of water. Shake or mix thoroughly. Use a hand or low-pressure power sprayer to give a heavy coating to flowers and foliage. Thoroughly cover treatment area to a point well above the reach of animals. To permit repellent film to properly set, apply under favorable drying conditions: 30 minutes before rain or watering, relative humidity below 70% and temperature above 40°F.

Thoroughly flush sprayer screens and nozzles promptly following use.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

Pesticide Storage: Keep Away from Children. Store in a cool, dry place.
