HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use Restriction: Non-food use only. Not for use on vegetables, herbs or fruit bearing trees.

Use DeerProTM Summer/Spring Deer Repellent as a repellent to reduce browsing and chewing damage from deer, rabbits, and voles (*Microtus* spp.). Repellency results from the odor of treated plant parts. One application will protect treated plants from 3-6 weeks, depending on weather conditions. Treat before the expected time of animal damage.

Thoroughly shake DeerProTM Summer/Spring Deer Repellent prior to use. Mix one part of formulation with 7 parts of water. Shake or mix thoroughly. Use a hand or low-pressure power sprayer to give a heavy coating to flowers and foliage. Thoroughly cover treatment area to a point well above the reach of animals. To permit repellent film to properly set, apply under favorable drying conditions: 30 minutes before rain or watering, relative humidity below 70% and temperature above 40°F.

Avoid overspray on house siding, patios and containers as product may cause staining.

Thoroughly flush sprayer screens and nozzles promptly following use.

- 1. Shake well before use.
- 2. Connect sprayer to garden hose.
- 3. Turn on water.

Spray

- 1. Extend to area to be treated.

- 3. Spray plant material to point of runoff.

Finish

- 1. To stop spraying, push & hold lock tab away from knob and use other hand to turn knob counter-clockwise to OFF position.
- 2. Turn off water at faucet.
- 3. Relieve water pressure in hose by turning sprayer back to ON position until water slows to a drip then turn sprayer OFF.
- 4. Disconnect sprayer from hose.]
