3. In the paragraph starting with "To control Cockroaches, ..." replace the word "dishwasher" with the word "dishwashers."

To control Cockroaches, Ants (except Carpenter, Fire, Harvester and Pharaon Ants) and Silverfish: Place a small spot approximately the size of a dime on inaccessible surfaces under or behind refrigerators, stoves, sinks, tubs, dishwasher, washing machines and dryers; into openings around drains, water pipes, electrical conduits; and in cracks and crevices around baseboards, corners of cupboards, cabinets, and closets. Remove lower drawers in kitchen and bathroom cabinets, bedroom dressers and place into corners of drawer wells. Reapply once/30 days if needed.
