Fill container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later disposal. Drain for 10 seconds after flow begins to drip. Repeat this procedure two more times. For containers greater than five gallons triple rinse as follows: Empty remaining contents into application equipment or mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip the container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand container on its end and tip back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or mix tank or store rinsate for later use or disposal. Repeat the procedure two more times. Then offer for recycling or reconditioning, or puncture and or dispose of in a sanitary landfill, or incineration, or if allowed by state and local authorities by burning. If burned, stay out of smoke.
