Revise the statements to appear in bulleted format. Additionally, place First Aid inside of textbox on page 21.

# (c) Page 2 – Environmental Hazards

Place language on page 3 inside of the text box so that appears on page 2. Or otherwise move the heading and text box to page 3, and incorporate language.

### (d) Page 3 - Directions For Use

Add the words "Shake Well Before Using" and remove from page 4.

# (e) Pages 3, 17, and 24 – Instructions

Add the word "General" prior to Instructions.

# (f) Page $4-2^{nd}$ paragraph

Bold the sentence: Use on all labeled non-bearing tree fruit and tree nuts.

## (g) Pages 5 and 10- Almonds and Pecans

Add 1 day Post harvest Interval.

# (h) Page 6 and 10- Beans and Soybeans

Move header to the next page for the respective crops.

# (i) Page 6 – Apples – Remarks

In the first sentence of the Remarks box for Pre-Harvest use to control Post-Harvest disease, add a space between "to" and "3

# (j) Page 7 – Beans – Remarks

Reformat the text in the Remarks box so that the line breaks do not leave one or two words stranded at the left margin.

## (k) Page 15 – Sugar Beets – Remarks

Change the beginning of the second sentence in the Remarks box to read "Mix Arc-TFan 4.5FL Fungicide with a protectant fungicide . . . "

### (1) Page 16 – Conifers – Remarks

For Pine, reformat the end of the last sentence in the Remarks box so that "a.i.)" is on the same line.

# (m) Page 17 – Directions for Use Through Chemigation Systems

In the heading beginning "Use in California by chemigation only for . . . ", delete the line break between "strawberries, and . . . " and "sugar beets."

# (n) Page 19 - Storage and Disposal - Container Handling

The text "Storage and Disposal Cont'd" appears in the middle of this section - delete it.

# (o) Page 22- Engineering Controls and User Safety Recommendations Place paragraphs inside of textbox.

### (p) Page 24 – Instructions and Information

Change the last sentence of the "Tank Mixing Instructions" section to "Avoid application in conjunction with highly alkaline fertilizers, such as aqueous ammonia, since they may cause degradation of the pesticide resulting in reduced performance.

# (q) Page 24- Turf Application

Remove the statement "Not for homeowner use. This statement is not enforceable.

# (s) Page 26 – Turf Application Table

In the Tees and Greens box for Anthracnose: basal and Anthracnose: foliar, add a horizontal line between "3.6 - 5.4" and "2-4".

## (t) Page 26 – Turf Application Table

In the Diseases box for Bermudagrass decline and Take-All-Patch, reformat so the disease names are appropriately hyphenated.

## (u) Page 27 – Turf Application Table

In the Instructions box for Gray Leaf Spot change "preventative" to "preventive."

### (v) Page 27 – Turf Application Table

In the Instructions box for Pink Snow Mold change "chlorthalonil" to "chlorothalonil."

# (w) Page 31 - Foliar Application Table for Ornamentals

In the Instructions boxes for Ovulinia Blight and Powdery Mildews add a space between "to" and "14".

# (x) Page 32 – Foliar Application Table for Ornamentals

In the Instructions boxes for Stem, Crown and Root Rots add a space between "28" and "to".

### (y) Page 33 – Foliar Application Table for Ornamentals

In the Instructions boxes for "Plant or Cutting Diseases caused by: ..." and "Bulb, Corm and Rhizome Rots caused by: ..." change "mm" to "minutes."

### (z) Page 35 – Spray Preparation

In the third sentence, add a space between "Arc-TFan 4.5FL Fungicide" and "in".

3. Submit one (1) copy of the revised final printed label before the product is released for shipment.

### INSTRUCTIONS AND INFORMATION

Apply ARC-TFAN 4.5FL FUNGICIDE with ground or aerial equipment, using sufficient volume of spray to provide thorough coverage. Continuous agitation is required to keep the material in suspension. Arcana LLC does not recommend tank mixes with highly alkaline pesticides, such as Bordeaux mixture or lime sulfur. No claim of compatibility with other pesticides is implied. Use the higher rate under conditions of severe disease pressure. Also, consult local State Extension Services for application schedules.

Use the fl. oz./Acre rate for concentrate sprays (less than 400 gallons on apples, less than 300 gallons on stonefruit). Use the fl. oz./100 gal rate for dilute ground applications. For aerial

applications, use a minimum of 5 gallons/A for row crops, and a minimum of 10 gallons/A for tree crops. For ground applications use a minimum of 20 gallons/A for row crops and 30 gallons/A for tree crops. Higher spray volume will generally result in better coverage and better disease control. Lack of control when using below minimum spray volumes is solely at the risk of the applicator/user, including use of electrostatic sprayers.

Tank mixing with a protectant fungicide may provide additional resistance management.

### **NON-AGRICULTURAL USE REQUIREMENTS**

#### INSTRUCTIONS AND INFORMATION

ARC-TFAN 4.5FL FUNGICIDE is a broad spectrum fungicide exhibiting preventative, curative, and systemic properties. It is useful on a wide variety of turf and ornamental disease problems. Apply ARC-TFAN 4.5FL FUNGICIDE with ground equipment, using sufficient volume of spray to provide thorough coverage. Use the higher rates under conditions of severe disease pressure. Also, consult local State Extension Services for application schedules.

Chemigation instructions follow Directions For Use. Read and follow these instructions carefully for this method of application.

Mixing instructions: Shake well before using. Some settling may occur during prolonged periods of non-use. When high pH tank mixes exist, minimize the interval between mixing and application. Buffering tank water to pH 6-7 before adding Arc-TFan 4.5FL Fungicide may enhance effectiveness. Add required amount of Arc-TFan 4.5FL Fungicide to partially filled tank (1/2 total volume), agitate by mechanical or hydraulic means, add tank mix product if used (see tank mix instructions below, agitate again and then add remaining required amount of water. Continual agitation will keep the material in proper suspension. For best results, use spray mixture the same day it is prepared.

Tank mixing instructions: ARC-TFAN 4.5FL Fungicide is compatible with most commonly used pesticides. If tank mixing with other materials, add products in the following order: wettable powders, dry flowables, liquid flowables, emulsifiable concentrates, and soluble materials such as fertilizers. No claim of compatibility with other products is implied. Do not tank mix with copper-containing materials or with highly alkaline pesticides, such as Bordeaux mixture or lime sulfur. Consult the intended tank mix partner product label for appropriate application rates and use instructions. Follow the label directions for the most restrictive of label precautions and limitations. This product may not be mixed with any product containing a label prohibition against such mixing. Read and observe the most restrictive precautionary statements and other information appearing on product labels used in mixtures. Avoid application in conjunction with highly alkaline fertilizers, such as aqueous ammonia, since they may cause degradation of the pesticide resulting in reduced performance. DO NOT USE PRODUCTS CONTAINING THIABENDAZOLE OR OTHER PRODUCTS CONTAINING THIOPHANATE-METHYL IN COMBINATION, IN ROTATION, OR AS A SUBSTITUTE FOR ARC-TFAN 4.5FL FUNGICIDE AS THEY ARE OF SIMILAR CHEMISTRY AND WILL CONTRIBUTE TO THE DEVELOPMENT OF RESISTANCE. If after using ARC-TFAN 4.5FL Fungicide according to label directions the treatment is not effective, a tolerant or resistant strain of fungi may be present. Discontinue the use of ARC-TFAN 4.5FL Fungicide for at least one season. As long as these precautions are followed, ARC-TFAN 4.5FL Fungicide can be useful for disease control, even if resistant strains are present.

TURF APPLICATION —Not for homeowner use. For use only by certified applicators or those under their immediate supervision. Do not apply with fixed wing or rotary aircraft. Not for use on turf being grown for sale or other commercial use as sod.

### Do not enter or allow others to enter until sprays have dried.

For use on all fine turf applications such as commercial and residential lawns, parks, athletic fields, golf course greens, tees, and fairways, and cemeteries, consisting of cool and warm season grasses such as Bentgrass, Bluegrass, Bermudagrass, Fescue, Ryegrass, St.

Augustinegrass, Zoysiagrass, or their mixtures. When used in accordance with the label, ARC-TFAN 4.5FL FUNGICIDE is not phytotoxic to any of the above mentioned grasses. ARC-TFAN 4.5FL Fungicide has both preventive and curative activity, and is to be used for the prevention and control of the diseases mentioned below.

Ground Application: Apply ARC-TFAN 4.5FL Fungicide with properly calibrated hand held, mechanical or motorized spray equipment or by chemigation through appropriate sprinkler irrigation systems. Spray uniformly over the area to be treated. Apply specified amounts in sufficient water to obtain thorough coverage of treatment area (2-4 gal of finished spray per 1,000 sq ft is suggested). When treating golf greens, always treat aprons and approaches. Use the highest recommended rate under conditions of severe disease pressure. For best results, apply after mowing or do not mow for at least twelve hours after application.

Lightly water the treatment area with one to two tenths inch of water to move the fungicide into active root zone. Excessive irrigation may move ARC-TFAN 4.5FL Fungicide below active root zone and reduce application effectiveness. Green design and drainage will influence irrigation practices. When tank mixing with contact action fungicides for foliar diseases, allow applications to dry on leaf surfaces. Proceed with normal watering after sprays have dried.

ARC-TFAN 4.5FL Fungicide is also effective as a pre-plant dip on cuttings and bulbs. For soil drench applications, best plant protection is achieved with preventative treatments repeated every 21 to 28 days. For foliar applications, begin treatments when disease first appears, or during

suspected periods of disease development. Make additional applications every 7 to 14 days or as otherwise instructed for the prevention or control of the listed diseases. Use of a wetting agent is recommended for plants that have leaves that are difficult to wet properly. Use of a spreader-sticker is recommended to enhance product performance in wet weather conditions or during periods of overhead irrigation. ARC-TFAN 4.5FL Fungicide may be used to control listed diseases on nonbearing "backyard" ornamental fruit and nut trees such as almond, apple, apricot, cherry, nectarine, peach, pecan, plum, and prune trees. ARC-TFAN 4.5FL Fungicide may be applied as a ground application using hand held, mechanical or motorized spray equipment, or as a chemigation spray or through an applicable sprinkler irrigation system; or as an aerial application where applicable. See specific instructions below.

Note: The "Directions For Use" of this product reflect the cumulative inputs from both historical field use and product testing programs. However, it is impossible to test this product on all species and cultivars. A preliminary trial is suggested on a small scale before a full treatment is applied to any plant type not shown on this label but found in a similar use site with a listed disease problem. Wait 5-7 days after treatment to evaluate results. This product is not recommended for use on Swedish Ivy (Nephrolepis exhaltata), Boston Fern (Plectranthus australis), and Easter Cactus (Hatiora gaertneri).

Some plants may occasionally show some sensitivity to ARC-TFAN 4.5FL Fungicide applications, primarily as seedlings. Symptoms rarely affect marketability of the plants. Please check compatibility under your conditions on small groups of plants to see if there is any sensitivity.

Application Instructions: Apply material with properly calibrated hand held, mechanical or motorized spray equipment or by chemigation thorough appropriate sprinkler irrigation, flood, or drip systems. Begin applications when disease first appears and repeat at 7-14 day intervals or as needed during the growing season. Use the shortest interval when conditions are unusually favorable for the development of disease. For hand held, mechanical, or motorized applications, mix 10 - 20 oz of ARC-TFAN 4.5FL Fungicide per 100 gal and apply as a full coverage spray to drip for the prevention and control of the diseases listed below. Spray volume may range up to 400 gallons of finished spray per acre depending upon plant species and plant growth stage. # DIRECTIONS FOR USE THROUGH CHEMIGATION SYSTEMS INSTRUCTIONS

Apply this product only through sprinkler irrigation systems including center pivot, lateral move, end tow, side (wheel) roll, traveler, solid set or hand move; or drip (mini-micro sprinklers, strip tubing, trickle) irrigation systems. Do not apply this product through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

If you have any questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Do not connect chemigation system (including greenhouse systems) used for pesticide irrigation to any public water system unless the pesticide label-prescribed safety devices for public water systems are in place. Public water system means a system for the provision of piped water for human consumption if such a system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

### SYSTEM REQUIREMENTS

Chemigation systems connected to public water systems must contain a functional, reduced pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe. Systems utilizing a pressurized water and pesticide injection system must meet the following requirements:

The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.

The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

### **APPLICATION INSTRUCTIONS**

Observe the requirements in the System Requirements section above.

Apply ARC-TFAN 4.5FL Fungicide only through systems containing anti-syphon and check valves designed to prevent water source contamination or overflow of the mix tank and containing interlocking controls between the metering device and the water pump to insure simultaneous shut-off. Maintain a gentle continuous agitation in mix tank during mixing and application to assure a uniform suspension.

Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute suspension per unit time.

Application of more than specified quantities of irrigation water per acre may result in decreased product performance.

Do not apply when wind speed favors drift, when system connections or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product cannot be flushed and must be dismantled and drained. In a center pivot system, block the nozzle set nearest the well/pivot/injection unit to prevent spray being applied to this area.

Where sprinkler distribution patterns do not overlap sufficiently, unacceptable disease control may result.

Allow sufficient time for pesticide to be flushed through all lines and all nozzles before turning off irrigation water.

ARC-TFAN 4.5FL Fungicide may be applied in conjunction with chemically neutral liquid fertilizers. Application in conjunction with highly alkaline fertilizers, such as aqueous ammonia, is likely to cause a degradation of the pesticide, resulting in reduced performance and should be avoided.

### SPRAY PREPARATION:

Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water. Prepare a suspension of ARC-TFAN 4.5FL Fungicidein a mix tank. Fill the tank with 1/2 or 3/4 the desired amount of water. Start mechanical or hydraulic agitation. Slowly add the required amount of ARC-TFAN 4.5FL Fungicide and then the remaining volume of water.

### **Sprinkler Irrigation - Notes**

Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
