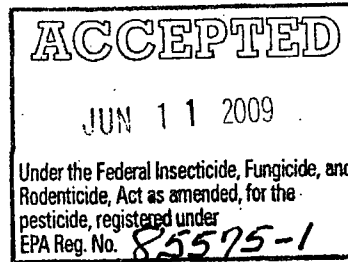

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product is designed as a general cleaner and sanitizer for use in homes, hospitals, nursing homes, assisted living facilities, schools, hotels, gyms, spas and other commercial venues. Use product on washable hard non-porous inanimate environmental surfaces: floors, walls, metal surfaces, glazed porcelain, Corian, Formica, stainless steel, plastic, glass, granite, and glazed ceramic tile.

FIRST CALL kills 99.9% of Staphylococcus aureus, (ATCC# 6538) including Methicillin Resistant (MRSA) (ATCC# 33591) and Klebsiella pneumoniae (ATCC# 4352) in 5 minutes.

TO CLEAN & SANITIZE: Remove gross filth or heavy soil prior to application of the product. Spray undiluted product 6-8 inches from surface until surfaces are thoroughly wet. Do not breathe spray. Allow surface to remain wet for 5 minutes. No scrubbing is necessary. Wipe with a damp cloth or sponge.

PRECAUTIONARY STATEMENTS

CAUTION: Causes moderate eye irritation. Avoid contact with eyes or clothing, wear safety glasses. Wash thoroughly with soap and water after handling and before eating, drinking, and chewing gum, using tobacco or using the toilet.
