

Poisoning with this product also results in cardiovascular and respiratory symptoms which must be treated as separate pathological entities apart from the cholinergic effects.

Use atropine sulfate to reverse cholinergic symptoms; maintain a systematic, symptomatic treatment of the cardiovascular and respiratory effects, even though the cholinergic symptoms have ceased. Pralidoxime (2-PAM) may be indicated as antidotal therapy. Contact a medical toxicologist, or poison center for guidance on the optimal utilization of 2-PAM. Do not give central nervous

system depressants. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. The use of oxygen is recommended in case of respiratory distress.
