STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, or disposal.

PESTICIDE STORAGE: Do not store below 25°C. Store in original container only. Product may crystallize at temperatures below 25°C (77°F). If product crystallizes, the material may be melted at room temperatures not to exceed 85°C (185°F). Keep container closed when not in use. Do not store near food or feed.
