When cyanosis is relieved, atropine may be administered in large therapeutic doses, repeated as necessary to the point of tolerance. If symptoms warrant further treatment, protopam chloride (pralidoxime chloride, 2-PAM chloride) has shown utility as adjunctive therapy. Never use morphine. Continued absorption of the poison may occur resulting in a fatal relapse after initial improvement. Very close supervision of the patient is indicated for at least 48 to 72 hours.

Forest trees [Forestry]: Plantations, forests, seed orchards, felled trees, cut stumps.

Commercial Livestock Housing: Cattle ear tags, poultry houses, turkey barns, swine barns, and dairy barns only.

B. NON-AGRICULTURAL, NON-TERMITE CONTROL USES:

Commercial Pest Control Indoors [Indoor Non-Residential]: Ship holds, railroad boxcars, industrial plants, manufacturing plants, food processing plants only.

Commercial Pest Control Outdoors [Terrestrial Non-Food, Non-Residential Commercial]:

- Underground utility cables and conduits.
- Turf and ornamentals in road medians; turf and ornamentals in industrial plant sites (provided the use rate is no greater than 1 lb. ai/acre).
- Interior treatment of warehouses, railroad boxcars, industrial plants, manufacturing plants, food processing plants only.

Turf [Terrestrial Non-Food]: Golf course turf, turf in road medians, and turf in industrial plant sites (provided the use rate is no greater than 1 lb. ai/acre).

Public Health Uses Only:

- USDA Quarantine Use: soil treatment of potted, containerized, or balled and burlapped nursery stock plants in nurseries and greenhouses only.
- Public health uses to control individual fire ant mounds and for mosquito control. Mosquito control may only
 be applied by trained personnel of public health organizations, mosquito abatement districts, public mosquito
 control programs, and professional pest control operators.
- C. OTHER USES: This product may be formulated into insecticide products for other uses for which the US EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration excluding any use strictly prohibited by this label.
