- b) The Disinfecting directions must be revised per DIS/TSS-15, Label requirements for antimicrobial pesticides used on hard surfaces:
- Revise "Disinfecting (hard, non-porous surfaces): ..." to read "*Remove gross filth or heavy soil. Spray product...*"
- c) Change "*Salmonella choleraesuis* to read "*Salmonella enterica*."
- d) ATCC designation numbers are required in one of the following locations:
- a. On the data matrix
  - b. On the master label (as optional text) with the listing of the organisms claimed; or
  - c. As the final page of the master label (as optional text).
- e) Revise the Precautionary Statement to read as follows:
- Caution: Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet.
- f) Revise "User Safety Recommendations" to read "User Safety Instructions" and "Users should" to read "Users must" per PR Notice 2000-5.

### Product Chemistry

The updates to the enforcement analytical method are acceptable.

Per the Product Chemistry review dated May 26, 2009, the following revisions must be made to the CSF:

- 1) You must submit to the Agency the one-year Storage Stability and Corrosion Characteristics once completed.
- 2) The upper limit for water must be changed from 100% to 103%, and the lower limit must be changed from 99.00% to 96.8% .
- 3) A unit of weight must be used on column 13a and/or box 17

Please see the attached DER for additional details regarding the review of the submitted data.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
