The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

Each roll of the screen is 328 ft (100 m) in length and 5 ft (1.5 m) in width.

Measure each side of the shelter/shed/pen/sty.

Determine the total length of the perimeter of the enclosure and determine the total length of the fabric required. Each roll of the screen is 328 ft (100 m) in length.

Determine the height of the shelter to be covered. Each roll of the screen is 5 ft (1.5 m) in width.

Unroll fabric and cut the desired length (plus additional 1 ½ ft (50 cm)). Start attaching the roll to the perimeter by using nails or heavy duty staples at 2 – 2 ½ ft (60 – 70 cm) spacing.

Keep bottom 4 in (10 cm) above ground before nailing or stapling.

Use Restrictions:

Do not open the original packing until ready to use. Do not allow children to handle the product.

The screen is intended for use only as a carrier of the incorporated insecticide and is not to be taken internally by humans or animals.

Deltamethrin 0.4% incorporated polyethylene screen, containing deltamethrin insecticide has been specially formulated using patented insecticide release technology. The screen kills stable flies (*Stomoxys* spp.) that may negatively affect livestock and other enclosed/secured animals. Stable flies are killed when they land on the screen where they contact and absorb the insecticide.

Prior to installation of the screen, measure the entire perimeter of the enclosure, including larval habitat. Cut the suitable dimensions of the screen and install it against the perimeter of the enclosure/area demarked by using nails or heavy duty staples. The dust accumulated on the screen can be washed by using mild non alkaline soap and with soft brushing. The effectiveness of the screen may get affected by dust accumulation and hence regular cleaning of the fence is recommended.

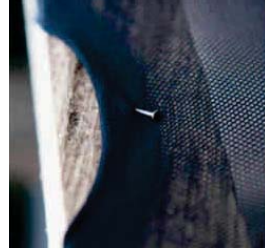
INSTALLATION GUIDELINES – Deltamethrin 0.4% Incorporated Polyethylene Screen



1. Measure each side of shelter / shed / pen / sty. Determine total length of fabric required. Measure height of shelter to be covered

3. Start attaching at edge of entry gate of shelter by securely nailing from bottom to top.

4. Keep bottom **4 in (10 cm)** above ground before nailing. If shelter height is less than **3 ft (1 m)** fold fabric inward at top. Do not fold bottom.



5. Hammer **1 in (3 cm)** nails through fabric leaving about **½ in (1.5 cm)** of nail protruding from board. Bend nail over, securing the fabric

6. Roll out fabric as needed. Make sure it is straight and tight against boards of shelter.

7. Continue hammering nails on top board. Space **2 – 2 ½ ft (60 – 70 cm)** apart. Keep fabric tight.

8. Once top is secure for a few meters pull fabric tight from below and hammer nails at bottom. Fix one section top and bottom then unroll as needed.



9. Keep fabric tight both vertically and horizontally. Do not let fabric sag. Do not stretch.

Special Conditions
10. Continue fixing around perimeter of shelter. Measure, cut and fix a separate piece of fabric to the gate. Cut fabric if necessary around other construction features.

Maintenance
Occasionally brush or wash fabric to prevent build-up of dust and dirt that will interfere with action of insecticide.
