DISINFECTION, DEODORIZING AND CLEANING

Remove gross filth or heavy soil prior to the application of this product. Hold container 8- 12 inches from surface to be treated. Spray area until it is covered with solution. Allow product to penetrate and the surface to remain wet for 10 minutes. Wipe off or let dry.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal
Storage: Store in an area inaccessible to children. Store at room temperature.
Wipe up spills with any absorbent material and dispose of as ordinary waste.
