The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable with the following comments:

- On page 3, under the "Important: Read Before Use" section, please change all references to the "Conditions" and "Disclaimer of Warranties and Limitations of Liability," so they read, "Warranty and Disclaimer Statement." This is the actual heading of the section referred to.
- On page 3, under the "Warranty and Disclaimer Statement" section, please change all references to "ALSA" so they read "Arysta." The text in the first paragraph indicates that "Arysta LifeScience America Inc." will be abbreviated as "Arysta."

A stamped copy of the label is enclosed. Please submit two copies of your final printed labeling before you release the product for shipment. Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e).
