# Page 2 EPA Reg. No. 86064-1

- a. On page 2 in the Environmental Hazards section, the sentence beginning "Chlorothalonil can contaminate surface water through spray drift. DO NOT apply when weather conditions", make that the beginning of a new paragraph by adding a space.
- b. On page 2 in the Environmental Hazards section, the sentence beginning "Chlorothalonil degradates are known to leach through soil into ground water under certain conditions as a" should be the beginning of a new paragraph.
- c. On page 3, top of the page, move the heading "General Precautions and Restrictions to the beginning of the sentence in the first paragraph.
- d. On page 3, second paragraph, delete the misplaced sentence "Use of this product on home lawns is prohibited."
- e. On page 3, in the Agricultural Use Requirements box, 6<sup>th</sup> line add "REI" after "and restricted-entry interval" and also add "(WPS)" to the end of the last sentence in paragraph 1.
- f. On page 3, in the Agricultural Use Requirements box, "waterproof gloves" must be changed to "chemical resistant gloves". Add "such as goggles, face shield, or safety glasses" to "and protective eyewear".
- g. On page 5, in the Mixing, Loading and Applying section, the following was omitted from the last sentence in this section: "except as directed in the Ornamental Plants section of this label.)"
- h. On page 6, the following was omitted and must be placed after the TANK MIXING section:

"Dipel is a registered trademark of Abbott Laboratories;
Foil is a registered trademark of Ecogen, Inc;
Latron and B-1956 are trademarks of Rohm and Haas Company:"
Copper Count is a registered trademark of Mineral research and Development Company"

Also change "No label dosage rates should be exceeded" to "Do not exceed any label rates".

- i. On page 8, and thereafter, the heading in the chart "Acre Rate Per" must be "Rate Per Acre". For dry beans; change the PHI from "14 7" to "14", delete "Botrytis blight (gray mold), Ascochyta blight" and the "2.73 pound" rate as it's not on source label; change "harvest-ed" to "harvested", delete "ring spot for carrot as it's not on source label.
- j. On page 8 and thereafter, delete "or as necessary" where it appears in the chart's direction for use (eg. snap bean, carrot).
- k. On page 9, corn (sweet), corn grown for seed; change "1.82 to 2.73 pounds" to "1.36 to 1.82 pounds"; after "Do not allow livestock" add "to graze in treated fields. Do not ensile treated corn or use as livestock forage. Do not apply to sweet corn to be processed."

- 1. On page 9, Cucurbits section, number 4, the word "increases" must be revised to read "increased."
- m. On page 10, Mint Application Directions, delete "or as necessary."
- n. On page 10, Mushroom beds Application Directions, line 2 "application" must be "applications", and line 5 "applications" must be "application."
- o. On page 11 Onion Application Directions, line 3, revise "de" to read "dew."
- p. On page 12, Soybean Disease section, "Diaporther" must read "Diaporthe" and "ercospora" must read "Cercospora."
- q. On page 14, Pistachio Application Directions, line 3 "fro" must be revised to read "for."
- r. On page 15, Conifers Direction for use, add a period to the end of the second paragraph and in the third paragraph 6<sup>th</sup> line "application" must be revised to read "application."
- s. On page 16, delete the first sentence in the Turfgrass section and add the following: "Do not apply to home lawns and turf sites associated with apartment buildings, daycare centers, playgrounds, recreational park athletic fields located on or next to schools (i.e. elementary, middle and high schools), campgrounds, churches, and theme parks. Do not use for sodfarms at application rates greater than 13 pounds of active ingredient, per acre, per year."
- t. On page 18, Foliage Plants, "Glaonema (1)" must be revised to read "Aglaonema."
- u. Page 19, change "All such risks shall be assumed by Buyer" to "To the extent consistent with applicable law, all such risks shall be assumed by Buyer".
- 3. Within 45 days, submit one copy of the revised final printed label incorporating these changes before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation, in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

#### **USER SAFETY RECOMMENDATIONS**

Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

## **ENVIRONMENTAL HAZARDS**

This product is toxic to aquatic invertebrates and wildlife. DO NOT apply directly to water, or to areas, where surface water is present or to intertidal areas below the mean high-water mark. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. DO NOT contaminate water when disposing of equipment washwater or rinsate.

Chlorothalonil can contaminate surface water through spray drift. DO NOT apply when weather conditions favor drift from treated areas. Under some conditions, it may also have a high potential for runo fauto surface water for several days to weeks after application. These include poorly draining or wet soils with readily visible slopes toward adjacent surface waters, frequently flooded areas, and areas overlaying extremely shallow ground water, areas with in-field canals or ditches that drain to surface water, areas not separated from adjacent surface waters with vegetated filter strips, and areas over-laying tile drainage systems that drain to surface water.

Chlorothalonil degradates are known to leach through soil into ground water under certain conditions as a result of label use. Use of this product in areas where soils are permeable, particularly where the water table is shallow, may result in ground water contamination.

#### **DIRECTIONS FOR USE**

#### **General Precautions and Restrictions**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DO NOT apply this product in a way that will contact workers or other persons, or pets, either directly or through drift. Only protected handlers may be in the area during applications. DO NOT allow people or pets to enter treated areas until sprays have dried or dusts have settled.

For any requirements specific to your State or Tribe, consult the Agency responsible for pesticide regulation. Use of this product on home lawns is prohibited. This product may not be added to paint by residential users/consumers.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

DO NOT enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours.

PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, such as plants, soil, or water, is:

- coveralls.
- · waterproof gloves,
- · shoes plus socks,
- and protective eyewear.

Special Eye Irritation Provisions: This product is a severe eye irritant. Although the restricted-entry interval expires after 12 hours, for the next 6 1/2 days entry is permitted only when the following safety measures are provided:

At least one container designed specifically for flushing eyes must be available in operating condition at the WPS-required decontamination site intended for workers entering the treated area.

Workers must be informed, in a manner they can understand:

- that residues in the treated area may be highly irritating to their eyes;
- that they should take precautions, such as refraining from rubbing their eyes, to keep the residues out of their eyes;

## NON-AGRICULTURAL USE REQUIREMENTS

The requirements in this box apply to uses of this product that are NOT within the scepe of the Worker Protection Standard for agricultural pesticides (40 CFR part 170): DO NOT enter or allow others to enter into treated areas until spray deposits have dried.

This product must not be applied within 150 feet (for aerial and air-blast applications), or 25 feet (for ground applications) from marine/estuarine water bodies unless there is an untreated buffer area of that width between the area to be treated and the water body.

Avoiding spray drift at the application site is the responsibility of the applicator. The interactions of many equipment-and-weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions. The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops. These requirements do not apply to forestry applications, public health uses or to applications using dry formulations.

The distance of the outer most nozzles on the boom must not exceed 3/4 the length of the wingspan or rotor.

Nozzles must always point backward parallel with the air stream and never be pointed downwards more than 45 degrees.

Where states have more stringent regulations, they should be observed.

The applicator should be familiar with and take into account the information covered in the <u>Aerial Drift</u> Reduction Advisory Information.

#### AERIAL DRIFT ADVISORY INFORMATION

#### INFORMATION ON DROPLET SIZE

The most effective way to reduce drift potential is to apply large droplets. The best drift management strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential but will not prevent drift if applications are made improperly, or under unfavorable conditions (see Wind, Temperature).

#### CONTROLLING DROPLET SIZE

- Volume- Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with higher rated flows produce larger droplets.
- Pressure- Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle
  types lower pressure produces larger droplets. When higher flow rates are needed, use higher flow
  rate nozzles instead of increasing pressure.
- Number of nozzles- Use the minimum number of nozzles that provide uniform coverage.
- Nozzle orientation Orientating nozzles so that the spray is released parallel to the airstream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase drift potential.
- Nozzle type- Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. Consider using low-drift nozzles. Solid stream nozzles oriented straight back produce the largest droplets and the lowest drift potential.

#### BOOM LENGTH

For some use patterns, reducing the effective boom length to less than 3/4 of the wingspan or rotor length may further reduce drift without reducing swath width.

#### APPLICATION HEIGHT

Applications should not be made at a height greater than 10 feet above the top of the largest plants urless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

#### **SWATH ADJUSTMENT**

When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the up and downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Swath adjustment distance should increase with increasing urift potential (higher wind, small drops, etc.).

#### WIND

Drift potential is lowest between wind speeds of 2-10 mph. However, many factors, including droplet size and equipment type determine drift potential at any given speed. Application should be avoided below 2

mph due to variable wind direction and high inversion potential. NOTE: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they affect spray drift.

#### TEMPERATURE AND HUMIDITY

When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

#### TEMPERATURE INVERSIONS

Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

#### INTEGRATED PEST MANAGEMENT

Armor Tech CLT 825 DF is an excellent disease control agent when used according to label directions for control of a broad spectrum of plant diseases. Armor Tech CLT 825 DF is recommended for use in programs that are compatible with the principles of Integrated Pest Management (IPM), including the use of disease resistant crop varieties, cultural practices, pest scouting and disease forecasting systems which reduce unnecessary applications of pesticides.

#### FUNGICIDE RESISTANCE MANAGEMENT

Armor Tech CLT 825 DF is effective for strategic use in programs that attempt to minimize disease resistance to fungicides. Some other fungicides which are at risk from disease resistance exhibit a single-site mode of fungicidal action. Armor Tech CLT 825 DF, with a multi-site mode of action, may be used to delay or prevent the development of resistance to single-site fungicides. Consult with your federal or state Cooperative Extension Service representatives for guidance on the proper use of Armor Tech CLT 825 DF in programs which seek to minimize the occurrence of disease resistance to other fungicides.

#### MIXING, LOADING AND APPLYING

Armor Tech CLT 825 DF is intended to be diluted into water, and then applied to crops by typical agricultural spraying techniques. Always apply Armor Tech CLT 825 DF in sufficient water to obtain thorough, uniform coverage of foliage and crop surfaces intended to be protected from disease. Spray volume to be used will vary with crop and amount of plant growth. Spray volume should normally range from 20 to 150 gallons per acre (200 to 1400 liters per hectare) for dilute sprays and 5 to 10 gallons per acre (50 to 100 liters per hectare) for concentrate ground sprays and aircraft applications. Both ground aircraft methods of application are recommended unless specific directions are given for a crop. Slowly invert container several times to assure uniform mixture. Measure the required amount of Armor Tecil CLT 825 DF and pour into the spray tank during filling. Keep agitator running when filling spray tank and during spray operations. Do not use on greenhouse-grown crops.

#### TANK MIXING

When tank mixing this product with other pesticides, observe the more restrictive label limitations and precautions. No label dosage rates should be exceeded. This product cannot be mixed with any product containing a label prohibition against such mixing. Do not combine Armor Tech CLT 825 DF in sprayer tank with pesticides, surfactants or fertilizers, unless your prior use has shown the combination physically compatible, effective and noninjurious under your conditions of use. Do not combine Armor Tech CLT 825 DF with Dipel 4L, Foil, Triton AG-98, Triton B-1956 or Latron B-1956, as phytotoxicity may result from the combination when applied to the crops on this label. DO NOT tank mix Armor Tech CLT 825 DF with oil, or with any adjuvants which contain oil as their principal ingredient. Do not use with Copper-Count N in concentrated spray suspensions.

# APPLICATIONS THROUGH SPRINKLER IRRIGATION SYSTEMS (CHEMIGATION)

Application through sprinkler irrigation systems is recommended only for those specific crops for which the notation "chemigation OK" is listed on this label.

Apply this product only through center pivot, motorized lateral move, traveling gun, solid set and portable (wheel move, side roll, end tow, or hand move) irrigation system(s). DO NOT apply this product through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

DO NOT apply this product through irrigation systems connected to a public water system. 'Public water system' means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days per year.

Controls for both irrigation water and pesticide injection systems must be functionally interlocked, so as to automatically terminate pesticide injection when the irrigation water pump motor stops. A person knowledgeable of the irrigation system and responsible for its operation shall be present so as to discontinue pesticide injection and make necessary adjustments, should the need arise.

The irrigation water pipeline must be fitted with a functional, automatic, quick-closing check valve to prevent the flow of treated irrigation water back toward the water source. The pipeline must also be fitted with a vacuum relief valve and low pressure drain, located between the irrigation water pump and the check valve, to prevent back-siphoning of treated irrigation water into the water source.

Always inject Armor Tech CLT 825 DF into irrigation water after it discharges from the irrigation pump and after it passes through the check valve. Never inject pesticides into the intake line on the suction side of the pump.

Pesticide injection equipment must be fitted with a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump. Interlock this valve to the power system, so as to prevent fluid from being withdrawn from the chemical supply tank when the irrigation system is either automatically or manually turned off.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check waive to prevent the flow of fluid back toward the injection pump.

The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Spray mixture in the chemical supply tank must be agitated at all times, otherwise settling and uneven application may occur. DO NOT apply when wind speed favors drift beyond the area intended for treatment.

Armor Tech CLT 825 DF may be used through two basic types of sprinkler irrigation systems as outlined in Sections A and B below. Determine which type of system is in place, and then refer to the appropriate directions provided for each type.

#### A. Center Pivot, Motorized Lateral Move and Traveling Gun Irrigation Equipment

For injection of pesticides, these continuously moving systems must use a metering pump, such as a positive displacement injection pump of either diaphragm or piston type, constructed of materials that are compatible with pesticides, fitted with a system interlock, and capable of injection at pressures approximately 2 to 3 times those encountered within the irrigation water line. Venturi applicator units cannot be used on these systems.

Fill chemical supply tank of injection equipment with water. Operate system for one complete revolution or run across the field, measuring time required, amount of water injected, and acreage covered. Thoroughly mix recommended amount of Armor Tech CLT 825 DF for acreage to be covered into same amount of water used during calibration and inject into system continuously for one revolution or run. Mixture in the chemical supply tank must be continuously agitated during the injection run. Shut off injection equipment after one revolution or run, but continue to operate irrigation system until Armor Tech CLT 825 DF has been cleared from last sprinkler head.

B. Solid Set and Portable (Wheel Move, Side Roll, End Tow, or Hand Move) Irrigation Equipment With stationary systems, an effectively designed in-line venturi applicator unit is preferred which is constructed of materials that are compatible with pesticides; however, a positive-displacement pump can also be used.

Determine acreage covered by sprinkler. Fill tank of injection equipment with water and adjust flow to use contents over a thirty to forty-five minute period. Mix desired amount of Armor Tech CLT 825 DF for acreage to be covered with water so that the total mixture of Armor Tech CLT 825 DF plus water in the injection tank is equal to the quantity of water used during calibration and operate entire system at normal pressures recommended by the manufacturer of injection equipment used for amount of time established during calibration. No agitation should be required. Armor Tech CLT 825 DF can be injected at the beginning or end of the irrigation cycle or as a separate application.
