This product may be used **only for formulation** into fungicides for the following uses: landscape ornamental flowers/shrubs/bushes, landscape trees and non-bearing fruit/nut trees, turfgrass (golf course, residential, institutional, commercial, municipal parks, recreation areas, airports, cemeteries, interior plant scapes, gardens, playgrounds, sod farms) and the following terrestrial food crops and crop groups: alfalfa, barley, berries low growing (subgroups 13-07A, 13-07B and 13-07G), Brassica head and steam vegetable (group 5-16), buckwheat, bulb vegetables (group 3-07), celtuce, corn (field, pop and sweet), cucurbit vegetables (group 9), Florence fennel (Florence), fruiting vegetables (group 8-10), kohlrabi, leafy vegetables (group 4-16), legume vegetables, succulent or dried; hay, vines, and forage (group 7), edible podded (subgroup 6A), and succulent shelled (subgroup 6B), leaf petiole vegetable (subgroup 22B), millet, oats, peas and beans, dried shelled except soybeans (subgroup 6C), oilseed (group 20), peanuts, pome fruit (group 11-10), root and tuber vegetable leaves (group 2) root vegetables except sugar beet (subgroup 1B), rye, sorghum, soybeans, stone fruit (group 12-12), sugar beets, teosinte, tree nuts (group 14-12), triticale, tuber and corm vegetables (subgroup 1C) and wheat.
