**Pesticide Disposal:** Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

## Container Handling:

Metal: Nonrefillable Container. Do not use or refill this container.

Triple rinse as follows: Empty the remaining contents into a container for mixing. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a container for mixing or store rinsate tcr later use or disposal. Repeat this procedure two more times.

Then offer for recycling, if available or reconditioning, if appropriate, or puncture and dispose of on site or at an approved waste disposal facility.
