Postemergence weed control on glufosinate-resistant crops including glufosinate-resistant canola, glufosinate-resistant field corn, glufosinate-resistant sweet corn, glufosinate-resistant cotton, and glufosinate-resistant soybeans and postemergence weed control on cotton with a hooded sprayer only.
