The above-referenced registrations, EPA Reg. No. 86230-1, 86230-2, 85495-1 and 85495-2 contain conditions calling for the registrations to expire two years from the date in the registration notice dated 1/10/11. The above-referenced registrations, EPA Reg. No. 2517-155 and 2517-156 contain conditions calling for the registrations to expire two years from the date in the registration notice dated 5/17/13. The terms of these registrations have been most recently updated to extend the expiration dates to May 30, 2019. Additionally, your company is required to adhere to the spot-on label mitigation, submit quarterly enhanced incident reports and quarterly sales information for each of the above registrations.

The Agency has found Sergeant's Pet Care Products, Inc. in compliance with the terms and conditions for the subject products. Therefore, the following change is being made to the terms and conditions of the products listed above:

- **The 2-year time-limited registration restriction has been extended an additional two (2) years. Therefore, the new expiration date for the subject product registrations is now May 30, 2021.**
