#### **General Information:**

For non-selective spot treatment of individual weeds. Visible effects occur soon after treatment, and actively growing susceptible weeds are controlled with 1-2 days. Leaves no harmful residue in the soil.

GROTEK™ ELIMAWEEED™ WEED AND GRASS KILLER is for control of undesirable plants in and around the garden, on patios, sidewalks, driveways, under fences, and around established trees and shrubs.

GROTEK™ ELIMAWEEED™ WEED AND GRASS KILLER controls the following:

Annual Broadleaf Weeds and Grasses: black medic, chickweed, cinquefoil (rough), common

ragweed, crabgrass, foxtail, lamb's-quarters, mustard, oxalis, and pigweed.

Perennial Broadleaf Weeds and Grasses: bluegrass, cinquefoil (silvery), dandelion, wild carrot, plantain (broad-leaved and narrow-leaved), quackgrass, toadflax, and tufted vetch.

**Application Directions:**

No dilution or mixing is required. For best results, apply in sunny warm weather to actively growing young weeds less than 4-inches high. Avoid spraying on windy days.

To apply, turn the adjustable nozzle to achieve the desired spray pattern. For most applications, use a coarse spray that can be targeted to uniformly and thoroughly wet only unwanted foliage. Complete coverage is necessary for best results. When spot treating, use a shield of cardboard or plastic around desirable plants.

To control top growth of dandelion and plantain in lawns, adjust nozzle to produce a straight stream spray pattern. Hold the container close to the weeds so that the stream can be controlled and spray just the center growing point of the weed. Grass that is sprayed will also be burnt but regrowth will occur.

Weeds that are mature, dormant or hardened due to moisture stress tend to be more tolerant to herbicide treatments. A repeat treatment of perennial regrowth and large weeds will be required.

Only contacted vegetation will be affected. Rainfall or watering within 1 hour of application will reduce degree of control.

**ATTENTION:** Avoid all contact to desirable plants. Overspray or drift will injure contacted foliage. If sprayed on desirable plants, rinse off with water immediately. Avoid application to reactive metals such as aluminum, tin, iron, or items such as fencing or lawn furniture in order to prevent staining, mottling or otherwise interfering with finished metal surfaces.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage and disposal.

**Storage:** Store in a cool, dry place. Keep from freezing.
