- 1. Submit and/or cite all data required for registration/reregistration of your product when the Agency requires all registrants of similar products to submit data.
- 2. Make the labeling changes listed below before you release the product for shipment
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 86314-1"
 - b. Per the Agency's product performance/efficacy review (copy attached), all claims and use directions against "cockroaches" or "roaches" must be revised to read "German cockroaches".
 - c. Per the Agency's acute toxicity review (copy is attached) you must revise the First Aid statement by adding the following statement:
 "If on skin: take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice."

Also, the "If in eyes . . ." statement may be removed. It may also be retained as optional language if desired.

- 4. Within sixteen (16) months of the date on this Notice of Registration, provide to the Agency acceptable data packages for Guideline Studies as follows:
 - a. OCSPP (formerly OPPTS) 830.6317, (Storage Stability) and 830.6320 (Corrosion Characteristics). The recommended observation periods are 0, 1, 3, 6, 9, and 12 month intervals.
 - b. OCSPP (formerly OPPTS) 810.3500 (Product Performance/Efficacy). A guideline GLP lab study must be submitted demonstrating adequate efficacy (>90%) of the product against German cockroaches. The protocol under which the previous study was conducted is mostly acceptable, but because the active ingredient acts slowly, the study should be maintained longer than 21 days (until adequate efficacy is observed). If the registrant desires to support addition of a general 'cockroach' claim, data for American cockroaches, *Periplaneta americana*, must be submitted with the amendment application. If the registrant wishes to submit such an amendment, with adequate data for American cockroach efficacy, such data would also fulfill the requirements for this condition of registration, if it is submitted within 16 months.
- 5. Submit two (2) copies of the finished labeling bearing the above stated revisions prior to releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.


