1. In the list of use sites in the second sentence of the "**DIRECTIONS FOR USE**" section, "Flower Crab" should be changed to "Flowering Crabapple"; and "Hawthorne" should be changed to "Hawthorn".

A stamped copy of the label is enclosed for your records.

Submit two copies of final printed labeling before releasing this product for shipment under the labeling accepted via this letter. Products shipped after 18 months from the date of this Notice or the next printing of the label, whichever occurs first, must bear this revised label.

If these conditions are not complied with, this registration will be subject to cancellation in accordance with FIFRA section 6(e).

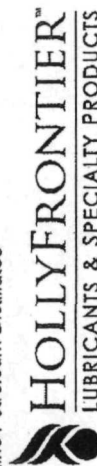
