

#### **Entry Restrictions**

Do not enter or allow any person, other than a person equipped with the appropriate handler personal protective equipment including appropriate respirator, to enter the treated area until the area has been ventilated. Ventilation may be for either a total of (2) hours with fans or other mechanical ventilation or four (4) hours with windows, vents, or other passive ventilation, or until such time that there have been 10 complete air exchanges. The ventilation may be interrupted, i.e., the time may be accumulated at sporadic intervals, such as 15 minutes of ventilation followed by a period of no ventilation, until the total required ventilation time has accumulated.
