3. Submit one (1) copy of the final printed labeling for the record before you release this product for shipment.
4. Submit storage stability and corrosion characteristics (Guidelines 830.6317 and 830.6320) data as these data requirements are not satisfied. A one-year study is required to satisfy these data requirements. You have 18 months from the date of this registration to provide these data to the EPA.
5. If, following consultation with the United States Fish and Wildlife Service, the Service identifies additional mitigation measures are necessary to prevent adverse effects to any listed species or their designated critical habitat, EPA will notify registrants in writing within 45 calendar days of completion of any such consultation of any necessary required changes. Pursuant to this proposed registration term, within 30 calendar days of receiving EPA's notice, registrants must submit an amendment application incorporating any required changes, including amended labels. Alternatively, Agrotecnologías Naturales S.L. must submit a request for voluntary cancellation of the product. 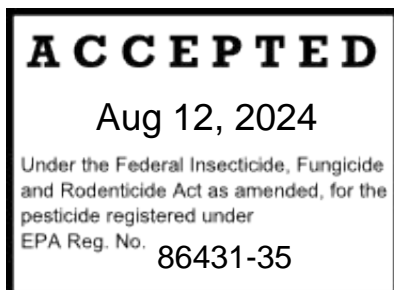
