On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Your draft labeling for the product, Consus Glyphosate Technical cannot be approved as submitted. However this product can be unconditionally registered in accordance with FIFRA section 3(c)(5) provided that you:

- 1. Submit and/or cite all data required for registration of your product under FIFRA sec 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for registration review of your product under FIFRA section 3(g).
2. Make the following changes to the label:
a. Change the product registration number to "EPA Reg. No. 86828-2".
b. Add the batch number to all products in disposable containers before shipment.
c. On page 1, in the first aid box, order the rows so "If in eyes:" is first, "If on skin or clothing" is second, and "If swallowed:" is last.
d. On page 2, change #4. to "Food Crop Uses (all crops in the following crop groups as listed under 40 Code of Federal Regulations (CFR) 180.41, Crop Group Tables)". Change the "Crop Group 4:" descriptor to "Vegetables, Leafy, except Brassica". Under "; "Non-crop areas", add "(except residential turf)" after "turfgrasses".


- e. On page 3, under the list of Tropical fruits, change "genip" to "marmaladebox (genip)". The tolerance is established on the crop name "Marmaladebox". Genip will be a synonym. Likewise, change "carambola" to "starfruit (carambola)".
- f. On page 3, in the "Miscellaneous crops:" paragraph, remove Jerusalem (sic) in the parenthesis for "artichoke", cardoon, chrysanthemum, marmalabox, mizuna, purslane, rutabaga, salsify, and starfruit, because either they have already been mentioned under "Tropical fruits", or they are included in the mentioned crop groups. Correct the typo for "teiff" to "teff".
- g. On page 3, remove the RoundUp Ready crops. There is a restriction on the label against formulating for RoundUp Ready Crops.
- h. On page 4, under "CONDITIONS OF SALE AND LIMITATION OF WARRANTY", add "To the extent consistent with applicable law," to the beginning of the last sentence in paragraph.

3. A stamped accepted label with comments is enclosed for your files.

4. Submit one copy of the revised final printed label for the record before the product is released for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

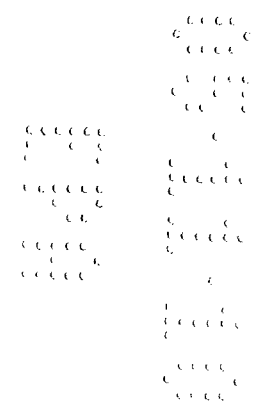
### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Only for use in the manufacture of herbicides for the following uses:

1. **Non-crop areas** such as rights of way, industrial, recreational and public areas (excluding residential turf), forestry site preparation and release programs, site preparation or direct sprays to the floor of ornamental nurseries and Christmas tree farms, rights of way (ROW), Conservation Reserve Program (CRP), turfgrasses and grasses for seed production; aquatic and wetland sites, eucalyptus and hybrid poplar productions, farmsteads;

- 2. Fallow ground, pastures, sods, and rangelands,
- 3. Residential sites;
