- b.) Revise the "Precautionary Statements" to read as follows: "Causes substantial but temporary eye injury. Harmful swallowed or absorbed through the skin. Do not get in eyes or on clothing. Avoid contact with skin. Avoid breathing vapor or mist. Wear goggles or face shield. Wash thoroughly with soap and water after handling and before eating, drinking, and chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
- c.) Revise the "Pesticide Storage" statements to read as follows: "Store in original container and in an area inaccessible to children. Keep container closed when not in use. Protect from freezing. In case of a leak or spill, soak up with absorbent, such as sand earth, or sawdust, and shovel into waste container. Remove waste to chemical waste area, and dispose in accordance with pesticide disposal instructions."
- d.) - e.) The "Container Disposal" section must be revised to be in compliance with the Container Rule by changing the subheading, Container Disposal, to read "Container Handling." Also, the first two statements in this section must state "Nonrefillable container. Do not reuse or refill."
- 3. Submit three (3) copies of your final printed labeling before distributing or selling the product bearing the revised labeling.

AMS BIGUANIDE 20 is diluted and applied to give 0.025-2.0% on the dry weight of the substrate. Application is by conventional means such as padding, spraying, soaking or exhaustion. The optimum conditions for application of the dilute solution are pH 6.5-8 and temperature of 20-30°C.

The following are examples of products (substrates) suitable for antimicrobial finishing with AMS BIGUANIDE 20:

Textiles such as: household products, for example, upholstery, carpet, curtains, wall coverings, mops, dishcloths, yarns, cords, toweling and blankets.

Cellulosics such as: wipes, tissues, sponges, paper products (non-food contact) such as fiters and cellule pulp.

AMS BIGUANIDE 20 Application rate to apparel items or clothing is not to exceed 2.0% by dry weight of the substrate to be treated. Apparel items include-

Apparel items such as: slacks, shirts, underwear, sweatshirts, sweatpants, socks, oven mitts, slippers, bathrobes, gloves, hats, scarves, jackets, sheets, pillowcases, incontinence pad cover stock, washable incontinence briefs and panties.
