

Gently and briefly depress trigger several times to prime tool ready for application of product to hives [picture 5]. Each pull of the trigger delivers a standard dose of 3 ml of product. Apply 2 doses of 3 ml per brood chamber/brood box. When product syringe is empty, replace with new product syringe. Retain dosing gun for future applications of Amiflex[®].
