Tip container on its side and role it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip back and forth several times. Turn the container onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

[For containers ≤ 5 gallons] Triple rinse as follows: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

HOUSEHOLD AND CONSUMER PRODUCTS: Use this product at levels of 250 - 2,500 ppm (2.5 - 25 lbs. This product per 10,000 lb. product) for the preservation of liquid and solid or paste consumer products such as surface cleaners, floor cleaners, disinfectant/sanitizers (non-food contact, hard surface uses), fabric stain removers, fabric softeners, fabric conditioners, laundry detergents, laundry additives, automotive care silicone emulsions and automotive cleaning products.
