This product is intended for formulation into end-use products for the following uses: (1) artichoke (globe), blackberry, boysenberry, raspberry, blueberry, alfalfa, clover, birdsfoot trefoil, crown vetch, sainfoin, head lettuce, endive, escarole, radicchio greens, rhubarb, apple, apricot, cherry, grape, nectarine, peach, pear, plum, prune, and winter peas; (2) established grass stands, CRP land, fallowland; and (3) ornamentals including woody ornamentals, nursery stock of ornamentals, Christmas trees, sod farms and non-residential turf.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store in a cool, dry place and in such a manner as to prevent cross-contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area. Handle and open container in a manner as to prevent spillage.
