#### WATER SOLUBLE PACKAGING INFORMATION

#### MIXING INSTRUCTIONS

Follow the steps below when mixing this product, including if tank mixed with other pesticide products. - 1. If a basket or strainer is present in the tank hatch, remove prior to adding the WSP to the tank.
