The amended label and CSF referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is attached for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

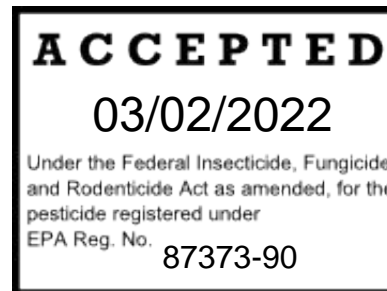

This pesticide is for the further manufacturer of formulated pesticides only. Formulators using this product are responsible for obtaining EPA registration for their formulated products. Only for formulation into a pesticide for the following uses:

1. **Terrestrial Food/Feed Uses:** Alfalfa (western US only*), Bermuda grass (west of the Rockies), cotton, beans (dry and succulent) (western US only*), field corn, sweet corn (including ears and forage) (western US only*), caneberry subgroup 13-07A, pepper/eggplant subgroup 8-10B including plants grown for transplant, small fruit vine climbing subgroup, except fuzzy kiwifruit 13-07F, low growing berry subgroup 13-07G, citrus group 10-10 (CA, AZ, and TX only), dates, grapes, hops, pome fruit group 11-10, potatoes (western US only*), sorghum (western US only*, including OK and TX), sugar beets (western US only*), timothy (west of the Rockies), wheat including triticale (west of the Rockies), tree nut group 14 and pistachios, stone fruit group 12, greenhouse tomatoes including plants grown for transplant.
2. **Terrestrial Non-Food Uses:** Christmas trees, ornamental plants, mature ornamental plantings and plants (Interiorscapes, Residences, Public Areas, Commercial Areas, Institutional Areas, Industrial Areas, Rights of way and other easements, and Recreational sites such as campgrounds, golf courses, parks and athletic fields), vines growing in nurseries or field grown, turf including ornamental lawns, turf grown for sod, turf grown to produce seed, turf for research purposes, non-bearing tree fruit, nuts, citrus, vines (including field-grown, greenhouse, nursery, and shadehouse).

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into the manufacturing equipment (or store rinsate for later use if it can be used in the manufacturing process). Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into the manufacturing equipment and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over the manufacturing equipment (or store rinsate for later use if it can be used in the manufacturing process).
