- 4. On page 2 under "Pesticide Disposal" delete "Do not reuse empty container".
- 5. On page 2 under "Container Disposal" add "Non-refillable container: Do not reuse or refill empty container".
- 6. Qualify tile, slate, terracotta, brickwork, concrete, concrete pool services as hard non-porous on pages 1, and 3 by stating glazed tile, sealed slate, sealed terracotta, sealed brick work, sealed concrete, non-porous pool surroundings.

Product Chemistry:

The revised basic CSF dated October 25, 2010 has been found to be acceptable. The Product label is required to address issues of chemical incompatibility which are associated with the active ingredient. A revised copy of the Product Chemistry Group A document has been found to be acceptable.


The Product Chemistry Group B data can be supported by using study data citations based upon similarity between this new product and to "Me-Too" product EPA Reg # 84115-1.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its label.

Read all Directions and Precautionary Statements before use.

30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away] is specifically formulated to kill Lichen, Moss, Mold & Algae on roofs & other exterior surfaces outdoors.

Shake contents before use.

Mix one part of **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** to five parts water (1:5 mix ratio).

Spray surface to be treated when surface is DRY, and rain is not predicted for 12 hours or longer.

Use a backpack or pump up tank sprayer to apply. Thoroughly saturate surfaces to be treated. To maximize coverage, remove excessive organic growth or clumps where possible, prior to applying Spray and Walk Away. This will save you money and increase the effectiveness of the product.

Once treated, the surface requires no pressure washing, scrubbing or rinsing. Just thoroughly wet the surface and **WALK AWAY**. Treated surface will show signs of decay over coming weeks and growth will erode away with the weather [elements]. Alternatively leave treated surface for a few days after treatment, then brush off decaying growth with a stiff brush.

After use, clean and flush applicator thoroughly with water.

If you prefer immediate results, we recommend **30 SECONDS Outdoor Cleaner**.

COVERAGE:

{One gallon of **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** concentrate makes a total of 6 gallons of Ready-to-Use product.}

{2.5 gallons of **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** makes a total of 15 gallons of Ready-to-Use product.}

{5 gallons of **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** makes a total of 30 gallons of Ready-to-Use product.}

{1 quart of **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** makes a total of 1.5 gallons of Ready-to-Use product.}

Coverage will vary based on severity of growth and porosity of surface to be treated. As a guide, Ready-to-Use product treats 750 – 2250 sq/ft.

ONGOING MAINTENANCE:

30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away] does not show immediate results, but works as a treatment, killing the growth slowly and effectively over time without damaging the surface. Some Lichen & Moss may take a week to remove or show signs of decay. If the surface to be treated is not fully exposed to rainfall or is vertical, then some additional wetting of the surface may be required. Re-application may be required where heavy growth persists. Do not repeat treatment more than six (6) times per year.

INDIVIDUAL SURFACE LISTINGS:

30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away] is primarily designed for treating Lichen, Moss, Mold & Algae on ROOFS; Composite, Tile, Terracotta, Shingles, Concrete, Metal, Masonry, Slate, or Plastic. **30 SECONDS Spray & Walk Away [30 SECONDS Wet & Walk Away]** will also work on other outdoor surfaces like pathways, brickwork, concrete pool surrounds, tombstones, non-grass tennis courts, astro turf, asphalt driveways, vinyl and aluminum siding, painted non-porous surfaces, non-porous textured finishes, wood decks.

ADVICE FOR SPECIFIC SURFACES

Wood Decks: Growth on Cedar or Redwood may require brushing for complete growth removal. Use water and a hard broom 1 month after application. Once cleaned, it may be maintained with Spray and Walk Away to prevent further growth or stains.

Golf Greens and Tees: Mix 1.3 oz of Spray and Walk away with 5 gallons of water. Spray on surface until thoroughly saturated. If necessary, repeat spray applications after 10 days. Treatment is not to exceed 10 acres (2000 gallons). Do not repeat treatment more than 6 times per year.

Residential Lawns/Turf: Use Spray and Walk Away as a spot treatment for algal/moss growth. Spray a solution of 5.1 oz of Spray and Walk Away per 5 gallons of water until surface is thoroughly saturated. If necessary, repeat spray applications after 10 days. Treatment is not to exceed 25 gallons per 1000 sq ft. Do not repeat treatment more than 6 times per year.

Play Equipment: Do not allow children on play equipment (i.e. slide, plastic gyms) if it has been treated with Spray and Walk Away, until the equipment has been washed down with fresh water, at least 24 hours after application.

Pets: Keep animals off treated surfaces until product has dried. If contamination occurs, rinse animals paws with fresh water to prevent animal licking Spray and Walk Away.

HELPFUL HINTS:

Staining on hard surfaces can occur, so always test on a small, inconspicuous area first.

30 SECONDS Spray and Walk Away is best applied in overcast, dry conditions to avoid rapid evaporation.

DO NOT allow spray to come into contact or drift onto plants or trees.

DO NOT allow pets to walk on treated areas until surface has dried. If contamination does occur, rinse animals' paws.

DO NOT allow product to enter lakes or streams or enter storm water drainage systems.

DO NOT use on roofs where potable water is collected.
