BEEF AND DAIRY CATTLE: For repelling flies and lice. **Emerion 8200 C8910 FA Dusting Powder** can be used in any commercially available dust bag or shaker can applicator.

For dust bags, cut open one end of the package and carefully insert the open end into the dust bag and allow the entire contents to fall out of the package and into the dust bag. One loading of 12.5 lbs. will last approximately 6 weeks for 30 head of cattle when the dust bag is hung in a gateway through which the animals pass daily for water. The bottom edge of the dust bag should hang approximately six inches below the top line of the cattle. Dust may become wet in heavy rains and form a cake; however, dusting will resume once the cake has dried and has been broken up from continued use by the cattle.

For shaker cans, cut open one end of the package and slowly pour the desired amount of **Emerion 8200 C8910 FA Dusting Powder** into the can to minimize aerosolized dust. Dust no more than 2 ounces (about six level tablespoons) to each animal over the head, neck, shoulders, back and tail area. Repeat as necessary. Continued use may result in longer retreatment intervals. Close the package with a clip to prevent loss of contents and store in a dry place.

STORAGE AND DISPOSAL
