Uses include but not limited to; Control or Burndown of Weeds and Grasses, as a foliage Desiccant, Harvest Aid, blossom thinning and as a plant Sucker Control. It is also an effective contact fungicide for powdery mildew, downy mildew, brown rot, fire blight, botrytis, late blight and leaf and fruit spot.

- Nursery Crops, Pastures, Ornamentals, Turf, Landscapes, Interiorscapes, Greenhouses, Parks, Golf Courses, Airports, Residential Sites, Commercial Sites, Educational Facilities, Farmsteads and Around Buildings and Industrial Site, Trees, Farms, Dry Aquatic Sites, Dry Drainage Systems, and around Aquatic Sites.

#### STORAGE AND DISPOSAL

**DO NOT** contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store container in cool place away from food, pet food, feed, seed, fertilizers, and veterinary supplies. Always store pesticides in the original container.

**Pesticide Disposal:** Wastes resulting from use of this product must be disposed of on-site or at an approved waste disposal facility.

Container Disposal: Clean container promptly after emptying.

Non-refillable Containers: Do not reuse or refill this container. Offer for recycling if available.

Non-refillable container equal to or less than 5 gals: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Non-refillable Container greater than 5 gals: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

**Refillable Container (5 gals or larger):** Refill this container with this pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. Dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
