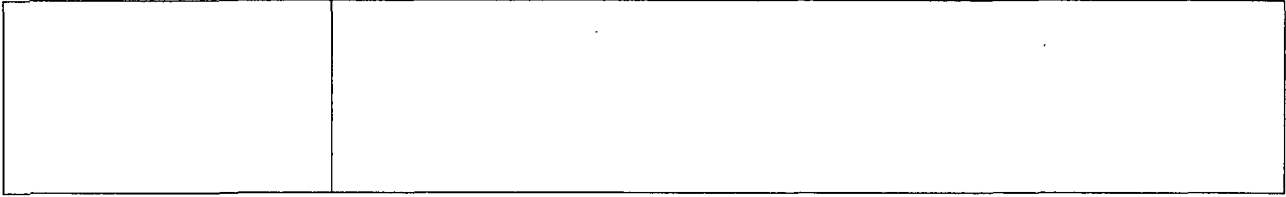

While spraying, fluff the hair so that spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes or face. Allow pet to dry before returning to cage. As pet dries, keep it in a warm area to prevent it from getting chills. Repeat if necessary.

#### STORAGE AND DISPOSAL
