The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. Although the Cancellation Order published on December 18, 2024, FRL Published, (FRL-12084-01-OCSPP) declared that EPA has previously approved the label containing this use deletion, the amended label is being approved with this letter. As of June 18,2025, you may only distribute or sell this product if it bears this new revised labeling, or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims

substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

(1) Terrestrial Food/Feed Crops: Asparagus, Banana, Barley (seed treatment and foliar treatment), Beans, Brassica leafy greens subgroup 5 B, Bulb vegetable crop group 3, Cherries, Corn, Cotton, Cucurbit Vegetables crop group 9, Fruiting vegetable crop group 8, Garden Beets, Grapes, Grasses Grown for Seed, Hops, Lychee, Mango, Oats (seed treatment), Okra, Peanuts, Pistachio, Plantains, Pome Fruit crop group 11. Sovbeans. Stone Fruit crop group 12. Sunflower, Tree Nuts crop group 14, Turnip, and Wheat (seed and foliar treatment). (2) Terrestrial non-food uses: Golf Course Turf, Flowers, Ground Covers, House Plants, Ornamental Trees, Ornamental Shrubs, Roses, Vines; (3) uses for which US EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; and (4) uses for experimental purposes that are in compliance with U.S. EPA requirements.

Restrictions: DO NOT package end use products in metal containers.
