

Mixing and Application Directions

Do not mix with water prior to application This product is to be applied dry and directly incorporated in the soil or broadcast spread to the soil surface as directed below Treatment area must be watered immediately after application

For established turf (including golf courses) – Apply 15 to 20 lbs per 1000 square feet using a lawn spreader or any other applicator that will ensure uniform coverage Calibrate spreaders for accurate output The best time to apply is when soil is dry
