The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. However, EPA reviewed only the label changes highlighted, marked, or otherwise indicated on the submitted label. Any other changes to the previously approved label that were not clearly highlighted, marked, or otherwise indicated in your submission were not reviewed and may form the basis of regulatory and/or enforcement action if later discovered by the Agency. Further, submission of a label amendment application with unidentified changes may be considered a knowing submission of false information to the Agency. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The label submitted with the application has been stamped "Accepted Only Indicated Revisions Reviewed" and is enclosed for your records.

This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 C.F.R. § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently

If the website contains any false or misleading statement, design, or graphic, the product may be misbranded and unlawful to sell or distribute under FIFRA Sections 2(q)(1)(A) and 12(a)(1)(E). 40 C.F.R. § 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on the product label, claims made as part of the product's sale or distribution may not substantially differ from those claims approved through the registration process under FIFRA Section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the product will be referred to the EPA's Office of Enforcement and Compliance Assurance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This labeling must be in the possession of the user at the time of pesticide application.

In the field do not remove the capsules from container until ready to apply. For best results transport the capsules in original sealed packaging until loading into Application Device.

Apply only with a SmartVetTM Approved Vetcap Application Device (sold separately), and in accordance with its use directions and treatment method recommendations.

Never leave the capsules in any Application Device – return all unused capsules to original container and store as directed.

Only apply when animal is between 15 feet and 30 feet distance from the user.

Do not use on wet cattle or when rain is expected to wet cattle within 24 hours after treatment.

Do not apply treatment when bystanders are within 30 feet of the animal.

Do not apply to any animals in or within 10 feet of bodies of water.

Do not leave intact capsules in the field.

Do not allow farm dogs or other farm animals to come into contact with the pesticide or residues.

AIM-L is designed for use only with a compatible applicator device that carries the 'SmartVetTM Approved VetCap Application Device' label. Using any other application device or method could be unsafe, ineffective and/or cause harm or injury.

How to Apply: Apply the capsules to the middle of the side of the animal's body anywhere between the front shoulders and 6 inches ahead of the base of the tail.

Amount to Use: Apply AIM-L at the dosages shown on the following table. Care must be taken to apply the correct dosage.

AIM-L can be used on beef cattle of all ages provided they are greater than 600 lbs. Treatment for flies [or lice] can be repeated as needed but not more often than once every 2 weeks and do not apply more often than four times within any 6-month period. [For optimal lice control, an initial application followed by a second treatment 2 weeks later is recommended.]

AIM-L does not control cattle grubs.

STORAGE AND DISPOSAL

Not for Use or Storage In or Around the Home

Do not contaminate water, food or feed by storage or disposal.

Pesticide Disposal:

Pesticide wastes are hazardous. Improper disposal of excess pesticide or rinsate is a violation of Federal law. Container Disposal:

Non-refillable container. Do not reuse or refill any parts of this container. Offer for recycling, if available. Puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

Pesticide Storage:

Store in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out of reach of children, preferably in a locked storage area.
