This letter is in reference to your requests dated August 4, 2021, and August 1, 2023, to extend the conditional time-limited registration for Exidot for Dogs (EPA Reg. No. 88051-4).


The above-referenced registration contains conditions calling for the registration to expire two years from the date the product was conditionally registered (i.e., September 15, 2023). Additionally, your company is required to adhere to the spot-on label mitigation, submit quarterly enhanced incident reports and quarterly sales information for the above registration.

The Agency has found Chanelle Pharmaceuticals Manufacturing Ltd. in compliance with the terms and conditions for the subject product. Your email dated December 21, 2023, stating that the product has not been released for shipment as of this date, has been added to the product's files. The Agency is therefore granting the request to extend the 2-year time-limited registration restriction. As such, the following change is being made to the terms and conditions of the product listed above:

- **The 2-year time-limited registration restriction has been extended an additional two (2) years. The new expiration date for the subject product registration is now September 15, 2025.**

This product is still subject to all other previous required conditions of registration. Those conditions include Agency review and approval of the mock-up labels. At least three months before your intended sale/distribution date submit a mock-up copy of the label. You may not sell/distribute this product until the Agency reviews and approves the mock-up copy of the label. Once the mock-up label is approved, you must inform the Agency when the product is first released for shipment.
