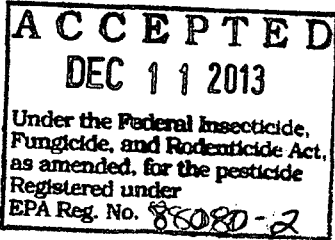

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read this entire label and follow all use directions and precautions.

USE RESTRICTIONS: This product may be used to repel pigeons, crows, magpies, starlings, and house sparrows from buildings facilities and adjacent structures. This product is applied on top of supplied plastic dishes. However, the product can be applied directly on window sills, roof lines, gutter edges, signs, ornamental copings, cornices, ledges, and similar surfaces where it is difficult to apply the supplied dishes. Wear disposable gloves when using this product. Apply Bird Free when temperatures are between 59-95 F (15-35 C). Do not apply this product in rainy or damp weather or in temperatures below freezing. Do not apply where repellent may entangle non-target bird species; on or near feeders, on vegetation/structures that are supporting feeders.

PREPARING SURFACES FOR TREATMENT:

1. To reduce potential exposure to bird-related diseases, wear waterproof gloves and a respirator approved by the U.S. Bureau of Mines for dust protection when cleaning areas to be treated. Prepare surfaces to be treated by removing bird nests, dirt, droppings and other debris. Using water mixed with a wetting agent or detergent, wet surfaces where droppings are present to limit generation of airborne dust during cleaning. Allow cleaned surfaces to dry fully prior to treatment as adhesive silicon or the repellent may be poor on wet surfaces.
2. If the repellent is to be applied directly on to the surface and not with the supplied plastic dishes, check the condition of the surface to which the repellent is to be applied. Treat porous surfaces such as wood, stone, or concrete with an undercoating such as paint or sealer before applying Bird Free. On asphalt or wood shingles, or on any other surface from which relatively easy removal of product is desired, apply waterproof tape or similar material first and apply the repellent to the tape rather than its substrate.

APPLICATION DIRECTIONS:

1. Put on disposable gloves & respiratory protection against hazards associated with bird excrement which is harmful to humans.
 2. Follow the steps in "PREPARING SURFACES FOR TREATMENT" to prepare the application site.
 3. After applying adhesive silicon or similar adhesives on the back of the supplied plastic dishes, fix the repellent-contained plastic dishes on the supplied surface at intervals of 7-22 in (10-50cm). Adjust the distances of the plastic dishes based on the concentration of birds- the more birds that are present, the closer together the plastic dishes are placed.

4. Latch Bird Free cartridge into caulking gun.
 5. Inject 0.53-0.70(15-20g) of Bird Free into each plastic dish.
 6. Re-inspect placements once a month to check on damage of the dish and effect of bird repellence.

CLEAN-UP: While wearing appropriate skin and respiratory protection, clean treated surfaces by removing tape (if used) and scraping off product, and clean with a disposable cloth soaked in soap and water. Remove the used dishes and follow the instructions in the Storage and Disposal section for proper disposal.
