- 2) You must present an image of the size dog on the front panel for the weight range and package fill volume for each of the package sizes.
- 3) A cat prohibition icon is needed on the front panel in a box at the same size as any marketing icons. The background of the box containing the cat prohibition icon must be yellow with black text Text must read as follows: "DO NOT USE ON CATS keep cats away from treated dogs for 24 hours. If applied or ingested, contact your veterinarian immediately."
- 4) The cat prohibition icon with the statement "DO NOT USE ON CATS" is needed in other areas as identified on the label.
- 5. Revise the data matrix in accordance with the Efficacy Review dated March 8, 2013.

If EPA determines that future mitigation measures are necessary for all pet spot-ons, the Agency will inform registrants. If mitigation measures are necessary, EPA may take regulatory action.

Two copies of the finished labeling must be submitted prior to releasing the product for shipment. 
