Proposed amendments:

Registrant is adding 8-ounce tablets and sticks and 7-ounce sticks to the previously-approved 7-ounce tablet form. Registrant is also adding alternate brand name "Pooline Trichlor Sticks."

General comments:





PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. Harmful if swallowed. Do not get in eyes or on clothing. May be fatal if inhaled. This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. - 1. This product emits a powerful chlorine gas. Do not open container indoors: Hold away from face when opening to avoid breathing fumes.

Do not mix with any other chemicals. Mixing with other chemicals may cause a violent and instantaneous chemical reaction.

PREVENTION OF PROPERTY DAMAGE:

Contact between this product in its undissolved state and vinyl liners, painted surfaces or other properly in or around the pool will result in permanent bleaching of color.

These [tablets][sticks] are manufactured with the most concentrated form of dry chlorine available today. They are consistent in size and slow dissolving when used as directed to allow you to reliably dose your pool once a week. These [tablets][sticks] allow you to easily maintain proper chlorine residuals and help you to effortlessly produce beautiful, clean sparkling water.

DIRECTIONS FOR USE

It is a Violation of Federal Law to use this product in a manner inconsistent with its labeling.

- 1. Adjust water pH to 7.2-7.6 as determined by a test kit. For pools with copper plumbing the best pH factor is 7.6-7.8
- 2. If the pool has not been previously stabilized add Conditioner and Stabilizer (cyanuric acid). Follow the directions for use on the label for that product.

UNSTABILIZED POOLS: Follow steps 1 and 2 and then add two (2) [tablets][sticks] per [6,500][7,500] gallons of pool water to establish a chlorine residual of 1.0-1.5 ppm as determined by test kit. Repeat dosages as needed to maintain a residual of 1.0-1.5 ppm at all times. Thereafter, add 1 [tablet][stick] per [6,500][7,500] gallons per week or as needed to maintain chlorine residual of 1.0-1.5 ppm at all times as determined by a test kit.

STABILIZED POOLS: Follow step 1 and then add 1 [tablet][stick] per [6,500][7,500] gallons, per week, or as needed to maintain a chlorine residual of 1.0-1.5 ppm at all times, as determined by a test kit.

Maintain some flexibility in dosing your pool as chlorine demand will vary depending upon factors such as air and water temperature, bather load, frequency and intensity of thunder storms and pool exposure. Shock your pool weekly during hot weather and less frequently in cooler periods according to instructions provided with the chosen product. Pool should not be entered until the chlorine residual is below 3.0 ppm.

Application should be made using one of the following methods:

FLOATING CHLORINATOR: Load floating chlorinator with prescribed dosage as per instructions on that chlorinator. Allow chlorinator to float freely in pool. Increase chlorination by increasing dosage or by securing chlorinator in an area of less agitation.

SKIMMER METHOD: Empty the skimmer of all chemicals and/or debris. Place prescribed dosage into skimmer basket. Length of filtration cycle will influence the rate at which the [tablets][sticks] dissolve.

IN-LINE EROSION CHLORINATOR: Load prescribed dosage into chlorinator according to instructions supplied with the chlorinator. Adjust the chlorinator control valves to always maintain the desired chlorine residual.

Please Note: The pH of these [tablets][sticks] is on the acid side and will tend to reduce the pH and alkalinity of pool water. Proper pH should be maintained at 7.2-7.6, through periodic additions of sodium carbonate or sodium hydrogen carbonate.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal

Pesticide Storage: Keep this product in a tightly closed container, when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. Retie polyethylene liner after each use and keep container tightly closed. In case of decomposition or spill isolate container in open area if possible and flood with large amounts of water to dissolve all material before discarding this container in trash.

[For Household/Residential Products]

[For Rigid Nonrefillable container 50 lbs or less]

CONTAINER HANDLING: Nonrefillable container. Do not re-use or refill this container. Triple rinse (or equivalent) promptly after emptying. Then offer for recycling, or reconditioning if available, or puncture and dispose of in a sanitary landfill, or by incineration.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

[For Commercial/Industrial/Institutional Products]

[For rigid Nonrefillable container greater than 50 lbs]

CONTAINER HANDLING: Nonrefillable rigid container. Do not re-use or refill this container. Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned stay out of smoke.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

[For Refillable Container]

CONTAINER HANDLING: Refillable Container. Refill this container with this product only. Do not reuse this container (drum) for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
