After September 21, 2015, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). ## Hazards to Humans and Domestic Animals

#### DANGER/PELIGRO

   Tobacco (burley and flue-cured).
- TERRESTRIAL AND AQUATIC FOOD: Alfalfa, Brassica (head and stem), Canola, Corn (field, pop, seed and sweet), Cotton, Fruiting Vegetable group (except cucurbits), Garlic, Legume Vegetable group, Lettuce (head and leaf), Onion (dry bulb), Peanuts, Pome Fruits group, Rice, Sorghum, Stone Fruits group, Sugarcane, Sunflower, Tree Nut group, Triticale, and Wheat.
