

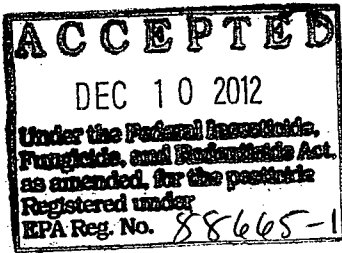

### GENERAL INFORMATION

For use as a porous surface (nonfood/nonfeed area), crack and crevice or spot treatment in, on and around commercial buildings and structures and their immediate surroundings. This product is not intended for use in residential areas, daycares, or schools. Product should not be applied to surfaces in which children may come into contact with.

**MIXING INSTRUCTIONS.**

Triton's Bugz-No-More Insecticide® is a suspension concentrate that must be diluted with - water before applying with - hand held or power sprayer - equipment to the sites and surfaces listed on this label. Refer to that table below for the amounts of water and Bugz-No-More Insecticide to add to prepare the desired amount of 0.06% deltamethrin finished dilution. The finished dilution must be agitated after mixing and before an application is made. Prepare only the amount of finished dilution needed. Do not store finished dilution overnight.-

**APPLICATION RECOMMENDATIONS**

**-Indoor Residual Surface Applications – Crack and Crevice and Spot treatment for control of Aedes spp. Mosquitoes**  
To control adult mosquitoes.

Apply Triton's Bugz-No-More® insecticide for mosquito-control at an application rate of 11 fluid ounces Triton's Bugz-No-More® per gallon of water, and apply at the rate of one gallon of dilution per 1,000 square feet as a general spray (refer to Triton's Bugz- No-More® Dilution Chart). Use this product for control of mosquitoes that may - transmit -, Dengue fever -.

Apply as a residual spray to inside surfaces of buildings including but not limited to, foundations, window frames, and other areas where mosquitoes are found. Apply with hand held and back pack sprayers. For best results apply when the mosquitoes are most active. Application during cooler hours of the night or early mornings is recommended.

Retreatment may be necessary to achieve/maintain control during periods of high pest pressure. Repeat application should be limited to no more than once per seven days.

Use a 0.06% suspension (11 fluid ounces to 1 gallon of water) for residual pest control in buildings and structures. Apply as a crack and crevice, pin stream, spot, coarse or low pressure sprays (25 psi or less).

**Resistance:** Some insects are known to develop resistance to products used repeatedly for control. Because the development of resistance cannot be predicted, the use of this product should conform to resistance management strategies established for the use area. Consult your local or state pest management authorities for details.
