#### **BEDNET ASSEMBLY**

Step 1. Spread bed net out on ground with ripstop floor facing down/ bed net mesh up.



Step 2. Assemble poles (2) and weave each through the black sleeves of bed net, criss-crossing to opposite footer pocket holds. Secure poles into opposite footer pocket holds.



Step 3. While each pole is secured in opposite footer pocket holds, stand up each pole and secure pole in footer pocket hold on the side closest to you. Repeat process with other pole, fully erecting the bed net.




# COT (optional) ASSEMBLY

Step 4. Open cot, but do not fully expand until it is inside of the bed net. Place one end of cot into bed net, then bring folded end into net opening (and expand cot).



Step 5. Weave one end-bar through cot sleeve, then the opposite end. Secure end-bars to cot. Snap in lower support-bars to cot (if provided).



## **BEDNET STORAGE**:

To return the bed net to its storage bag, it is recommended that the following folding pattern be used after removing the support poles:

Spread out bed net evenly (as in Step 1). Fold lengthwise both ends to midline. Fold ends to midline. Fold over at midline, and once again for placement in storage bag.

NOTE: Cot is not included in the Egret Bed Net assembly kit

### **CARE & WASHING INSTRUCTIONS**
