[Bed Bug Treatment] Tips

- Identify
 - <u>Usually, the first sign of bed bugs is itchiness from bites. It is difficult to identify bed bugs from just the bites but being bitten several nights in a row may be an indication that you may have bed bugs.</u>
 - Inspect areas around bed for physical evidence of bed bugs. Look for adult bugs (size and shape of an apple seed), nymphs or eggs (white, translucent, ~1.5mm in length). Also look for cast-skins or dark brown/black "pepper-sized" bed bug fecal spots.

- Sort

- All loose items in the room are ideal places for bed bugs to [nest and] hide. Sort
 all loose items into launderable and non-launderable items and seal them
 separately in plastic garbage bags (free of tears/holes).
- Remove everything from bedroom closet(s), dresser drawers, nightstands and dressing tables. Sort them into launderable and non-launderable items (e.g. electronics, books, etc.) and seal them separately in garbage bags.
- Strip bed(s) and seal all linens, pillowcases, mattress pads, blankets and drapes into garbage bags.
- Once the room is free of all debris and loose items, pull all furniture (e.g. beds, nightstands, chairs, etc.) away from the walls. Separate drawers from furniture, and separate mattresses and box-springs from bed frames.

- Treat

- [If your vacuum has a HEPA filter or can filter particles as small as 0.09 inches (2.5mm the size of bed bug eggs),] vacuum the room thoroughly to remove all visible bed bugs and debris from floors, cracks and crevices, under furniture, under bed legs, and around the room's perimeter where the wall meets the floor. [A vacuum that can filter particles as small as 0.09 inches (2.5mm the size of bed bug eggs) is recommended to avoid spreading bed bug eggs or small nymphs.] After you have finished vacuuming, carefully remove the vacuum bag and seal into a plastic bag for disposal. Do not use a bag-less vacuum. Inspect the vacuum, attachments and hoses before storage.
- [Open Surfaces:] Spray all floor surfaces (including floor underneath furniture), the room's perimeter and all other cracks and crevices with an insecticide labeled for use against bed bugs and eggs (PROOF Bed Bug and Dust Mite Killer).
- [Furniture] Use TER-RTU3 Bed Bug Pad to treat furniture that can fit into the provided treatment bag. Alternatively, you can treat all surfaces of large, heavy furniture with a spray insecticide like Proof Bed Bug & Dust Mite Killer. Always follow the spray insecticide's label carefully.
- [Launderable Items:] Carefully transfer all launderable items from garbage bags to a laundry dryer. Tumble dry on high heat for 30 minutes or longer to kill bed bugs and eggs. Then wash them. [Always heat-dry first, then wash.] Alternatively, these may also be treated with TER-RTU3 Bed Bug Pad inside a [treatment] [garbage] bag.
- [Non-launderable Items:] Open garbage bags containing all non-launderable items and treat them with TER-RTU3 Bed Bug Pad.

- It is a good practice to apply a light dusting of diatomaceous earth in all cracks and crevices in the room, including under furniture, under bed legs and around the room's perimeter where the wall meets the floor.

Reduce Your Risk of Bed Bug Infestations:

Precautionary Measures

In your bedroom:

- Bed bugs can't fly or jump so eliminate bed bug travel routes like sheets/bedding touching the ground.
- Move your bed/headboard and nightstand away from walls, drapes or other items that bed bugs might use to travel onto your bed.
- Bed bug interceptors may be placed under each bed leg to stop bugs from climbing up your bed from the floor. Note: Bed bug interceptors will not work if bed bugs are already living on the bed's mattress, box-spring or bed frame (in this case these items need to be treated directly).

- It is recommended to apply a light dusting of diatomaceous earth along the room perimeter where the wall meets the floor, and inside cracks of bed frames, furniture, and all other tight areas where bed bugs typically hide. Diatomaceous earth is a naturally occurring, chalk-dust like powder that slowly kills bed bugs that walk over it
- Reduce the number of bed bug [hiding] [nesting] spots in the room regularly clean up loose items from floors, launder clothing and bedding and vacuum floors.

When bringing items into your home:

- Bed bugs and their eggs can travel on used furniture, clothing, books, luggage, and most other items that move from an infested room to a new location. Beware of items when the origin is unknown.
- If you are moving used furniture or other items to a new location, it is advisable to treat these items before introduction to the new location.
- Small furniture and other items can be easily treated by sealing them into treatment bags along with **TER-RTU3 Bed Bug Pad** to kill any bed bugs or eggs that may be present in those items.

When travelling:

- At your destination, inspect mattress seams, headboards, bed frames, electrical sockets and night stands around bed for bed bugs or bed bug droppings (tiny, raised black/brown spots stuck to surfaces around cracks and crevices).
- Luggage and clothing should always be placed away from the bed and off of the floor, [inside a PROOF Bed Bug-Proof Dryer Bag or] [inside a sealed plastic bag to prevent bugs from entering the luggage and clothing inside]. Placing luggage and clothing inside a bathtub will also reduce the chance of infestation because bed bugs can't climb up the slippery surface.

Upon returning home:

- Clothing should be sealed inside [a PROOF Bed Bug-Proof Dryer Bag,] an escapeproof bag and transferred to a clothes dryer on high heat for 30 minutes to kill any bugs and egg. Alternatively, clothing may be sealed inside a treatment bag along with TER-RTU3 Bed Bug Pad to kill any bed bugs or eggs that may be present in those items
- Luggage and non-launderable items should be sealed inside a treatment bag along
 with TER-RTU3 Bed Bug Pad to kill any bed bugs or eggs that may be present in
 those items.
