- c. Under the "Hazard Statement:
 - i. Delete the word "Danger".
- ii. Add "Avoid breathing spray mists" to hazard statement after, "Do not get in eyes...or clothing."
 - iii. Delete "Do not breathe vapor."
 - iv. Delete "Do not give any liquid to the person."
- 4. Submit one (1) copy of the revised final printed label before the product is released for shipment.
