

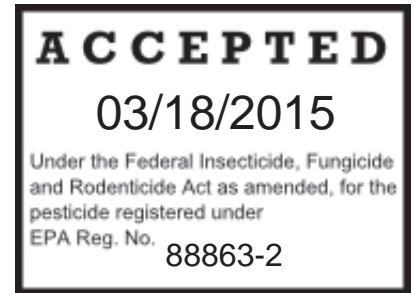

Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed. Harmful if inhaled or absorbed through the skin. Causes moderate eye irritation. Avoid contact with eyes, on skin or on clothing. Prolonged or frequently repeated skin contact with the active ingredient, trifluralin, may cause allergic reaction in some individuals. FIRST AID

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read the entire label before using. Do not apply this product in a way that will contact workers or other persons. Only protected handlers may be in the area during application.

PRODUCT INFORMATION:

GrasStopper is a multi-year root control system that is strategically positioned in the soil to prevent migration of Bermudagrass and other grasses from lawn areas into adjacent/perimeter planting areas. This includes along curbs, near non-food ornamentals, and along sidewalks. GrasStopper controls roots by establishing an in-soil barrier plane of trifluralin, which prevents root tip cell division. Roots are either stopped or redirected away from the GrasStopper barrier ribbon product. The multi-year feature of GrasStopper is provided by a time-release mechanism that continues to meter trifluralin into the soil as the soil trifluralin biologically and chemically degrades.

The product consists of continuous 3-foot segments of polyethylene ribbon containing the root growth inhibitor trifluralin. Trifluralin will not affect the growth of nearby ornamentals, but will inhibit lateral root growth of lawn grasses near the buried ribbon.

INSTALLATION DIRECTIONS:

Correct installation of this product is important to its functional longevity of 15 years in normal irrigated soils. GrasStopper is installed by employing a Dutch hoe or garden spade to create a 0.5-inch wide by 5-inch deep trench to place the 4-inch wide barrier at the perimeter of control. It is important that there is one (1) inch of soil above the top of the ribbon. The barrier ribbon produced is cut to the length of the trench, placed into the narrow trench, and sealed by tamping or compacting the adjacent soil firmly. Each successive 3-foot ribbon should be overlapped by one (1) inch.

PRECAUTIONS:

Product may cause staining to skin or clothing. GrasStopper is ready for in-soil installation as received. Install the ribbons into soil as soon as practical after removal from the sealed shipping package. The longevity of the product is temperature dependent, so do not expose the shipping package or ribbons to direct sunlight or temperatures above 90°F for an extended period of time. Store any unused portions of the product tightly resealed in the original container in a dry place.

RESTRICTIONS:

- Do not use adjacent to vegetable gardens or other planting areas for food.
- Do not install GrasStopper near natural waters or water sources.

STORAGE AND DISPOSAL:

Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store only in original container. Store in dry/cool place below 90 degrees F., out of sunlight, and out of reach of children.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER HANDLING: Completely empty container. Then dispose of wrap and/or box in a sanitary landfill or by incineration, or, if allowed by State and Local authorities, by burning. If burned, stay out of smoke. Non-refillable container. Do not reuse or refill this container.
