Only for use in Bird B Gone Bird-Out dispensers. Only for outdoor use and in buildings with openings that permit bird access.

Place the Bird B Gone Bird-Out dispenser in the area where pest birds are present. Follow the instructions as provided by Bird B Gone in the dispenser for appropriate installation and use.
